Welcome, Prayer & Introductions	Members were asked to introduce themselves and share with the group something they are grateful for.
Meeting Minutes – Review	December 2, 2020 minutes were reviewed and approved by Hector Ramirez and seconded by Robyn Gomez.
Capacity Building Projects – Updates	<ul> <li>Kelly Wilkerson shared with the group that the three Statements of Work for the capacity building projects; Wellness Forums, Outreach and Engagement Toolkit, and Needs Assessment, have been completed and reviewed by the stakeholder lead (Pinki Mehta).</li> <li>The Toolkit project is currently with Internal Services Department (ISD), which is the final stop before the projects go out for solicitation.</li> <li>Kelly has been checking the status daily on the internal website and will keep the subcommittee posted.</li> </ul>
COVID-19 Community Check-in	<ul> <li>Hector Ramirez shared with the group that he will be participating on a call with the Governor of California to advocate for people with disabilities to have early access to the COVID-19 vaccine, if they choose to take it.</li> <li>April Skinas shared that the United American Indian Involvement (UAII) received 100 doses of the COVID-19 vaccine from Moderna. Priority goes to healthcare workers, providers, staff, elderly, and those at higher risk. You must be a registered client of UAII.</li> <li>Monique Castro shared with the group that Los Angeles County is trying to get more vaccines out to Native American community members, through the LA county COVID-19 response group and the Indian Commission. They will be working on more remote locations to make it more accessible to community members.</li> <li>To help with the grief and loss due to the pandemic, starting the end of January or the beginning of February 2021 through the LA County COVID-19 response group, they plan on starting a Grief and Loss support group for community members in Los Angeles County.</li> <li>Data gathering effort: To collect more data regarding the Native community on usage and accessibility of the COVID-19 vaccine. In Native American communities, people are concerned with what is in the COVID-19 vaccine and what are the side effects.</li> <li>Sunnie Whipple shared that the Native community needs to know where they are at and how far they have come. He is in agreeance on collecting the data on usage and accessibility of the COVID-19 vaccine.</li> </ul>

## Monique Smith shared with the group that ECHO ended their four-year contract. They screened over thirty-two thousand people and conducted a lot of virtual education and were able to support and give out supplies to the community.
