Miscellaneous Updates:

Rosario Ribleza shared with the group a brief background on Measure J.

- November 3, 2020 Los Angeles County voters approved measure J. which allocates at least 10% of the County's locally generated and restricted funding.
- Residents and stakeholders will be able to elevate their priority funding needed for their communities to thrive. They will be able to share their ideas, priorities and recommendations.
- Funding priorities vary and may include; Community Health Services, Community Counseling, Youth Development programs, Affordable Housing, Supportive Housing, etc.
- The Measure J Re-Imagine L.A. Advisory Committee is pleased to announce that it's five subcommittees will begin meeting the week of February 8, 2021: 1. Economic Opportunity and Sustainability 2. Housing 3. Reentry 4. Diversion, Behavioral Health, & Health 5. Education Access and Youth Development
- Dr. Sandra Chang informed the subcommittee that the department is working very closely with other departments in response to different motions by the Board of Supervisors.
- Health Workers should be the first to receive the COVID 19 vaccination, especially those working directly with the public.

Questions Regarding Calls Received: Access Center's Response:

The sign language appointments are scheduled for all services including initial intake, ongoing therapy, case management and medication appointments.

- The role of Access Center is to schedule Sign Language interpreter appointments for Directly Operated (DO) clinics and Contract clinics when they request for the services.
- The Access Center is a 24/7 Call Center whose function is to schedule appointments in response to requests from providers. Once appointment is scheduled, their job is completed.
- **Amy Kay** gave an update regarding 5 Acres' Deaf Services Programs annual review. Forty-two percent of 5 Acres clients that received services were adults.

- 5 Acres served more deaf and hard of hearing adults than children.
- The Department of Mental Health contracted 5 Acres to provide services to deaf and hard of hearing adults, but now they are no longer providing 5 Acres with that specific funding.
- There is a huge need for services for Adult deaf and hard of hearing particularly during this pandemic when schools conduct virtual learning.
- Dr. Sandra Chang will follow up with information she may gather, and share with the subcommittee.

Update on Cultural Tradition & Connections Newsletter:

- Dr. Sandra Chang gave an update on the Cultural Tradition & Connections Newsletter. They have been gathering input from the different subcommittee groups.
- The model of the newsletter is "FROM COMMUNITY FOR COMMUNITY." It is about sharing cultural traditions and building cultural connections amongst others.
- A full-page section is dedicated to each of the UsCC's.
- They are still looking for any articles, reflections, poetry, quotes and any kind of content that the subcommittee would like to share.
- The newsletter will be shared in a virtual form as well as hard copy.
- First release date is in mid-March, and the next one will be in June 2021. The deadline for submission will be in May for the June newsletter.

Promoters: Follow-up Meeting with Dr. Partida – Roque Bucton;

- One of the concerns is the accessibility of the application for disabled individuals who want to apply for the position.
- There was a request for DMH's contact person to assist in completing the application, or a suggestion that DMH staff complete the application for the applicant.
- Roque shared that he is going through the process of applying for the Promotora position but has not heard anything back from the department.

Community Resource Center – Roque Bucton;

- Roque completed his internship at the Disability Community Resource Center (DCRC) in January 2021 and received his Disability Peer Specialist certificate training.
- DCRC is doing a Digital Bridge program and will be handing out 300 free Chromebooks to people with physical and mental disabilities.
- Application process is simple. He encouraged qualified individuals to apply.
- Some projects that DCRC is working on: t1)The Community Emergency Response Preparedness for people with disabilities and 2)The Domestic Violence Peer Support Group.

Report: Current Number of Access for All Members – Rosario Ribleza

	Currently there are about 60 Access for All members, but only 12 to 15 are active.
