- If applicable, license-waivered status with employer to expire within 12 months
- Previous attempt(s) at passing the CA LPCC Law & Ethics Exam •
- The majority of work assignment is allocated to providing direct services in public mental health ٠

INSTRUCTIONS:

- 1. Scroll down for the application form, which must be completed, scanned and emailed to mhsawet@dmh.lacounty.gov along with documentation (i.e. eligibility letter from the licensing board, or a copy of board issued renewable APCC registration) indicating board approval to take the exam. Applications will be accepted until when capacity is reached.
- 2. An e-mail confirming receipt of application will be sent to all applicants.
- 3. Upon approval, participants will be given a website to register and pay the non-refundable fee of \$50 by VISA. MasterCard, American Express, Discover, or PayPal to the Gerry Grossman Seminars.
- 4. The Gerry Grossman Seminars will register participants for the study package and mail the study materials to the address provided on the application when payment is received.
