| American Indian / Alaska Native (Al/AN) USCC Co- Chairs Presentation | Shannon Rivers gave a presentation on "Indigenous Peoples/First Nations Facts Sheet For the Poor People Campaign". The members of the AI/AN subcommittee would like for all the UsCC subcommittees and other groups within DMH to understand the relationship on why indigenous people continue to be erased during larger discussions on some of the problems they see in the country. Shannon shared that Native people were considered to be recognized as "other". The document presented was initiated by Dr. Martin Luther King Jr. before he was assassinated. Shannon encouraged the subcommittee to go over the document together and participate by reading it. He feels that by reading it together, the important content can be better absorbed |
