General Updates:	A. DMH Updates – Pinki Mehta
Pinki Mehta	<ul> <li>1. Access Center Budget (Text Messages Platform):</li> <li>Pinki explained in detailed how to navigate through the DMH website; 24/7 Access help line – (800) 854-7771; and Text: LA to 741741 - Text Messages Platform.</li> </ul>

- There is a \$3.5 million funding comes from the MHSA plan to modernize the Call Center to make it more user friendly.
- Following questions were raised:
  - a. Hector Ramirez: Who responds to the incoming text messages?
  - **b.** Roque Bucton:
    - i. What are the security measures for the text messages?
    - ii. Is there some sort of direct messaging or instant messaging for deaf and hard of hearing individuals to remain anonymous?
- Pinki will consult with the Public Information Office (PIO), and provide feedback to the group at the next Access for All meeting.

#### 2. Update on Promoters Program:

- Currently there are 18 Black and African Heritage Promoters, 11 API, 2 AI/AN, and 56 Latino Promoters.
- Current language capacity: English, Spanish, Korean and Mandarin.
- Pinki suggested to invite Dr. Partida to the next Access for All meeting to discuss on how to reach out to the Disabled community.

#### 3. AB 803 - Peer Specialist:

- The State has been collecting information from different organizations in different Counties.
- The department provided feedback on Peer Certification SB 803 and the next step is to engage at the County level.
- Roque Bucton inquired about those who were certified prior to the passing of SB 803, and how the Update and Maintenance of Certified Status is going to work.
- Pinki will inquire for more information on pre-qualification and report next meeting.

# Updates on the Capacity Building Projects:

- 1. Mental Health Needs Assessment for the Physically Disabled.
- 2. Mental Health Needs Assessment for the Deaf and Hard of Hearing.
- 3. Mental Health Needs Assessment for the Blind, Partially Sighted and Visually Impaired.
- All projects were awarded to Painted Brain, and will be implemented simultaneously from July 1, 2021 until June 30, 2022.
- Rosario shared that the vendors who will be awarded with the 2021-2022 Capacity Building Projects: Podcast Series, Talking Circle, and Domestic Violence Taskforce, have to abide by the Health Insurance Portability and Accountability Act (HIPAA) law to protect the privacy of the participants.

Discussion:	<ul> <li>A. Barriers to Workforce Development for the Deaf &amp; Hard of Hearing</li> <li>Amy Kay suggested the following:</li> </ul>
	<ul> <li>a. Focus on recruiting deaf and hard of hearing individuals who know ASL and can work in this capacity.</li> </ul>
	<ul> <li>b. Reach out to High Schools and Colleges for recruitment and inform the students the career availability for the Deaf and Hard of Hearing community.</li> </ul>
	Hector Ramirez recommended the following:
	<ul><li>a. All services must be ADA accessible.</li><li>b. DMH must develop a more community-based services or programs.</li></ul>
	c. All Interpreters and Captioners should be certified and maintain their certification.
	Roque Bucton shared an application called, "Be My Eyes" for the visually impaired community.
	B. Plans for Face-to-Face Meetings:
	As of June 15, 2021 the State Mandate "Stay at Home" order was lifted.
	<ul> <li>Roque Bucton asked if Covid 19 vaccination is required for a face-to-face meeting.</li> <li>Dr. John Flynn stated that DMH has not yet received instructions from the Department of Public Health (DPH), but it may be discussed in tomorrow's Town Hall meeting.</li> </ul>
	<ul> <li>DMH is on the work of testing "hybrid" meeting – a combination of face-to-face and virtual meetings.</li> <li>The group voted to use Hybrid meeting model. It saves travelling time and more accessible to host the meeting. Participation will continue to increase because of the convenience of meeting virtually.</li> </ul>
Review UsCC By-laws – Election of Co-Chair	<ul> <li>Rosario Ribleza announced that Roque Bucton's term as Co-chair will end soon.</li> <li>The Access for All subcommittee needs to vote for a new Co-Chair.</li> </ul>
Liection of Go-Ghair	<ul> <li>The Access for All subcommittee needs to vote for a new Co-Chair.</li> <li>Rosario will work on summarizing the Access for All attendance from the last 9 months to determine who are eligible to vote, and who qualifies for Co-chair nomination.</li> </ul>
	<ul> <li>Members were strongly encouraged to review the UsCC by-laws particularly the Co-chair's qualification and duties to help them decide who they want to nominate.</li> </ul>
	<ul> <li>Qualified members who are also eligible to vote can nominate themselves if they can fulfill the duties of a co-chair.</li> </ul>
