#### **Welcome & Introductions**

• Subcommittee Members, Housekeeping, Attendance, Co-Chairs

Review of Meeting Minutes: Johana Lozano motioned to approve the minutes without corrections, Dr. Andy Ying made a second motion to approve

#### Cultural Calendar Presentation - Dr. Lee

- Calendar to honor and to celebrate everyone's culture unsure of origins of idea
- Reviewed calendar and provided examples of dates already included for final inclusion
- Presented rough draft information was gathered from "different groups"
- API UsCC co-chair shared concerns of calendar being drafted without input from API community, including API UsCC
- Community member shared concerns about inaccurate information being presented in draft of calendar
- Stakeholder asked for draft of calendar to provide feedback, Dr. Lee reported she was unable to share calendar with the community
- Community discussed importance of highlighting the diversity and rich culture of the API community
- Community reiterated the importance of reviewing the draft to ensure accuracy and transparency before calendar is finalized
- Dr. Lee will ask Dr. Sandra Chang to see if she authorizes Dr. Lee to share draft of calendar with API UsCC stakeholders

### **Involuntary Hospitalization (LPS)**

- Dr. Guzman briefly reviewed LPS laws and discussed process for involuntary hospitalization
- Co-Chair shared the sensitive nature of topic within API community and the importance of privacy and rights of individuals

- Pastor Kim shared this topic is discussed at Korean community round table including the concern about safety for community members in Korean town.
- Requested training for community members when faced with situation where individual is having a mental health crisis, especially for community leaders
- Request to provide training and awareness/education to faith-based leaders in API community
- Community expressed need for more API PMRT staff to be recruited and trained
- Additional request for DMH to reinstating PMRT for existing clients, especially those in FSP programs
- Community member shared incident calling police during a mental health crisis of a client and shared deep reservation of calling police to respond again because of negative experience
- Mental Health Family Mission helps support API family members with loved ones experiencing mental health issues
- Increased funding and support for family members is needed in API community so request for DMH to provide more support in this area
- · Pastor Kim suggested next year's capacity building project focus on supporting family members of API clients

## **Dr. Rocco Cheng**

- Dr. Cheng provided an update on the capacity building project on gathering and recording stories of resilience and recovery by API community members
- Community provided feedback and details to consider before finalizing story collection process
- Question about participant and their stories being representative of API experiences
- Community shared concerns about dissemination of information and stories once projected is completed
