Issues on Awarding Capacity Building Projects to Vendors

The projects are awarded to the vendor with the lowest bid.

- Lowest bidders oftentimes are not the best vendors, resulting to poor quality outcome.

 *Recommendation: incorporate the "cost effectiveness vs quality" in every project proposal.
- Lack of qualified vendors who can implement the projects.

Recommendation: increase contracting network and ensure that professionals get adequate money for services rendered
