#### **DMH Updates**

- Working on getting all the projects those approved (For all UsCC's groups)
- Capacity Building Projects have been increased to \$350,000
- Looking at the procedures we've been using in the past and how to identify the projects within each group.
- MHSA Team plans to incorporate a monthly training to cover internal and external process related to MHSA and the three year plan. To ensure that the community understands the process better.

## Black Mental Health Task Force: Nakeya Fields/Imani Bradley

- Awarded the Minding our Village Elders and the Empowering Black Family Series of Events, which has ended.
- Transitioning to finishing up the Minding our Village Elders.
- Trained 15 peer community service leaders which are now in the community providing workshops both virtually and in-person. Providing two workshops every week until the end of May.

- There is a policy work group that meet every other Tuesday, led by Rayshell Chambers of Painted Brain.
- Working on CalAIM and CARE Court, making sure equity and fairness is involved in the development.
- AAIMM Maternal Mental Health support group every fourth Wednesday, there is an art therapy component.

#### African Coalition Update: Senait Admassu

- Immigrant and refugee communities' surveys have been completed, only a few surveys were received.
- The pandemic made it difficult to locate spaces in-person to do some of these workshops.
- We've been able to meet the minimum requirements of two and it's been averaging, about six participants per workshop.
