- Hector also shared regarding a second talking circle project for individuals experiencing mental health conditions (i.e. disabled/neurodivergent communities).
- Recommendation from Mikey Fields to include an intergenerational component in any project proposals.
- Rex Wilde shared regarding a project idea for a music album to be created by and for disabled and neurodivergent communities. This would involve personal stories of mental health and resilience.
- Hector recommended that DMH consider canceling projects or Purchase Orders if vendors are not meeting the requirements outlined.
- Kelly to send out capacity building project proposal guidelines and vendor registration instructions. Any capacity building project proposals should be sent to Kelly via email prior to the August meeting (8/4/22). All proposals will be shared during that meeting and then the group will move towards voting/ranking.
