What are the most frequent diagnostic categories of your client population?

The Los Angeles County Department of Mental Health (LACDMH) provides mental health services county-wide through directly operated and county contracted clinics. The most frequent diagnostic categories of DMH's client population are psychotic disorders, mood disorders and severe anxiety disorders. Please note, students will not provide direct services to clients in this internship, however, will engage in macro work that impacts the service delivery to LACDMH clients.

What specific (perhaps unique) training opportunities do students have at your agency? Project planning, community capacity building, evaluation, program development, research, and training. Students will have the opportunity to observe how micro systems and direct practice interact in a large bureaucratic system at the County, State and Federal level.

What evidence based practices or theoretical orientations will students be exposed to at this site?

Students will be exposed to macro practices focusing on systems theory in which they have the opportunity to observe how micro systems interact in a bureaucratic agency. Students will gain experience in how civil service administrators navigate and oversee these micro systems (budget, direct client services, contract administration etc.) while ensuring proper linkage and communication throughout the system.

Do students have the opportunity to work in a multidisciplinary team environment that includes those with lived experience?

Yes. This agency provides an opportunity to work with various disciplines and work in a team environment as well inclusive of Social Workers (licensed and registered), Psychiatrist, Psychologist, Nurses, support staff, paraprofessional staff, and management staff.
