#### iii. Mundo Maya presented the PSA Campaign for Indigenous Community

- Proposal seeks to produce a series/campaign of PSA's (public service announcements) in Spanish and Indigenous languages aimed at immigrant communities where the characters that deliver the message are faces and voices with which their diasporas can identify, either because they are known, leaders, or because they identify with the image of origin.
- 2. PSAs present viewers with daily life opportunities to listen, analyze, talk about Mental Health, or symptoms that they or someone close to them are experiencing. They can talk to a friend, family, doctor, etc.

## iv. Generations in Action presented the "Beauties of Los Angeles" Documentary proposal

- 1. The Beauties of Los Angeles" is a 30-minute documentary that will demonstrate the resilience and persistence of 10 older women (65+).
- 2. The purpose of this documentary is to use the concept of oral history, providing lessons and examples to the new generations on how to overcome the difficult tests of life and live a fulfilling life.
- 3. The goal is to invite the audience to have intergenerational conversations with their families as they learn from the experiences of these interviewees and about the importance of mental health and well-being

### Fentanyl, Opioids, and Narcan – Amanda Cowan

#### A. Empowering Communities During the Opioid Crisis

- i. Knowing how to respond to an overdose means you are more likely to act and save a life if/when the time comes. Learning this form of intervention fosters an environment of safety, whether in a public or a workplace setting.
- ii. Amanda provided historical overview and timeline of Overdose Crisis
- iii. California had the fourth highest number of drug overdose deaths in the nation, 4,868 in 2017; the age- adjusted state mortality rate of 12.3 deaths per 100,000 people, however, was lower than the U.S. rate overall (per our population, per capita) In 2018, CA had the highest overdose numbers in the nation at 5,348 fatal overdoses. These numbers have continued to rise with around 10,000 Californians fatally overdosing in 2021. 5731 of those were fentanyl-related overdose.
- iv. Shared information about Opioids, risk factors for opioid use/overdose and discussed life-saving treatment (Naloxone)
- Presented I-CARE model to help people who are overdosing:
- ii. Identify an overdose
- iii. Call 911
- iv. Administer Narcan
- v. Rescue breathing (personal choice)
- vi. Ensure safety while waiting for EMS
- vii. Discussed importance of Latino community knowing how and where to get Naloxone and had to administer it
- viii. Schools have access to Naloxone through Department of Public Health; the community can also reach out to DPH to request it for free
