  - o The Panthera Project vendor has scheduled the cohort meetings throughout June and July.
  - o Black LGBTQ+ Community Outreach & Engagement Project currently in final phase, will be completed by June 30<sup>th</sup>.
  - Bi+ Affirming Mentorship and Storytelling Lab solicitation will occur in July.
  - o Transforming Community Care: API LGBTQ+ Mental Health and Wellness Project solicitation will occur in July.
  - o Proyecto Mariposa Monarca solicitation will occur in July.
  - o Two-Spirit Storytelling Project solicitation will occur in July.
  - Co-designed Project a survey was sent out to voting members with the ideas brainstormed at the May meeting. Based on those survey results, the final project will be focused on housing (safe, accessible) – in addition to the broader LGBTQIA2-S community, targeted populations will include the transgender community, two-spirit community, and commercial sex workers; the project will involve listening sessions.
