# CONFUSED ABOUT UNIFORM METHOD OF DETERMINING ABILITY TO PAY (UMDAP)?



### When is The Initial Liability Period UMDAP Re-Evaluation Date and New Liability Period?

Revenue Management Division (RMD) has created the attached annual liability schedule to assist you in properly completing the Payer Financial Information (PFI) form. Line 22 asks for the annual charge period. Page 22 of the Financial Screening Manual describes this as follows:

"The annual liability period runs from the date of the client's first visit (regardless of when the patient's financial information is completed or for an adjustment) until the last day of the eleventh subsequent month."

For example, a client received services at a mental health facility on December 16, 2010. The client's first visit is on December 16, 2010; the last day of the eleventh month from December 16, 2010 is November 30, 2011. Using the table, look for December 1-31, 2010; December 16<sup>th</sup> falls within this period. Line 22 of the PFI should be:

#### ANNUAL CHARGE PERIOD: FROM 12/16/2010 TO 11/30/2011

Read across the table and the UMDAP re-evaluation date would be December 1, 2011. The new liability period would be December 1, 2011 – November 30, 2012.

The attached table will help you fill out line 22, as well as help you determine the UMDAP re-evaluation date and the new liability period.
