- Provide face-to-face feedback and ongoing technical assistance to clinicians, Supervisors and their Program Head
- Improve overall staff performance by identifying and addressing individual and group training needs
- Attend staff meetings and offer group trainings to DMH staff
- In collaboration with the QA Manager and Quality Assurance team, develop necessary curricula on documentation, quality of care and other topics for which there is an identified training need
