CRITERIA & ELIGIBILITY

Criteria — The County of Los Angeles Department of Parks and Recreation, LA84 Foundation and American Red Cross will be providing a limited number of youth swim lesson scholarships for children ages 5-17 years. **Scholarships are limited to available funds and spaces.** Scholarships are awarded on a first-come, first-serve basis until limited funding is exhausted.

- Awardees are not guaranteed their first selection. Swim lesson placement will be determined by available space. Applicants should select up to (2) sessions their participant will attend in order of preference, if applicable.
- Once awarded, the funds can only be used from June 18, 2022 through June 30, 2023 youth swim lessons. Applications expire on June 30, 2023.
- Any unused scholarship will be considered forfeited, and will not be available the following year or for any other recreation programs, nor can they be transferred to other family members.
- Class cancellations must fully adhere to County policy as stated on your ActiveNet registration receipt.
- If any participants misses 60% of the classes in one session, they may be dropped from that session and forfeit that amount of the full scholarship.

Eligibility — Any resident within Los Angeles County is eligible to apply for the Swim Lesson Scholarship with youth in their household ages 5-17. Those who meet the guidelines and provide all necessary documents are eligible. Children are required to attend a minimum of 60% of the classes in order to retain scholarship. If children do not meet the required attendance, please notify staff immediately.

- If participant drops below the required attendance, their scholarship status will be put under review. A second occurrence of low attendance can result in removal of your scholarship allocation.

If you wish to remove your child from the program, you are required to submit a "Drop Notice" form at least two (2) weeks prior to the program start date. The "Drop Notice" form can be obtained at parks.lacounty.gov/dpr-scholarships

HOW TO APPLY

1. Submit your completed youth scholarship application (one form per household) two weeks prior to the class session you are signing-up for. A minimum of one week is required to review scholarship applications. Applications not submitted by the two-week deadline will be considered for the next session.

2. Applicants must submit a complete application, with verification of approved enrollment in a financial assistance program that lists the name of the applicant and household members as listed on the scholarship application. Verification outside the current program year will not be accepted. Applications will not be accepted unless verification of enrollment in financial assistance is uploaded.

Applicant must provide proof of acceptance in any of the following financial assistance programs:

3. Your application will be processed and reviewed for approval. Submitting an application does not guarantee that a scholarship will be awarded after submittal via email of the scholarship status and the ActiveNet account will be updated to the participant. Scholarship applications must be approved before enrolling into classes. Applicant will be notified within 5 business days.

4. If the scholarship application is approved, the discount will be awarded upon completion of ActiveNet registration. Award of a scholarship does not guarantee enrollment and does not replace the registration process. 5. Families must apply annually for scholarships.

Attendance Policy — Children are required to attend a minimum of 60% of the classes in order to retain scholarship.
