

#### Excitement greets the opening of the Eastern Ridgeline Trail at Kenneth Hahn State Recreation Area.

As a staff member at the Baldwin Hills Conservancy, Gloria Dangerfield is well-acquainted with Kenneth Hahn State Recreation Area. That's why her reaction to the newly-opened Eastern Ridgeline Trail, as she walked briskly around its walking path on a recent morning, took on a particularly meaningful resonance.

"I can see the results of all the hard work and time involved to create a wellpaved walking trail -- which was sorely needed -- and the delightful outdoor equipment and sculptures," she said. "This will truly contribute towards making Kenneth Hahn State Recreation Area a world-class park to be enjoyed by visitors and residents for decades. I personally utilize the trail and other walking trails on a weekly basis, as well as employees from Verizon whom work in my office park. Kudos to you for a project well done!"

Similar sentiments held the day on Sept. 20, as Los Angeles County Board of Supervisors Chairman Mark Ridley-Thomas, Department of Parks and Recreation Director Russ Guiney, Baldwin Hills Conservancy board members and a host of others were on hand to dedicate the new Eastern Ridgeline Trail.

Funded by a Proposition 40 grant

provided by the Baldwin Hills Conservancy, along with a grant from Chairman Ridley-Thomas' office, the ¾-mile walking trail is the first completed segment of the planned "Park to Playa" Regional Trail. When fully completed, the Park to Playa trail will be the first non-vehicular route from Baldwin Hills to the Pacific Ocean.

"This \$3 million investment will make Kenneth Hahn State Recreation Area more accessible to all the communities that live on its east side – including the residents of View Park and Windsor Hills," said Ridley-Thomas. "No matter what time of day it is, the views along the ridgeline are incredible and will give users a great taste of what the entire 'Park to Playa' experience will be like once the regional trail is completed."

Along the scenic Eastern Ridgeline trail, visitors to Kenneth Hahn State Recreation Area will find amenities that include a play area tailored for families; four fitness zones with exercise equipment; child-friendly animal sculptures; benches for relaxation; and native, drought-tolerant landscaping. The project also includes accommodations in accordance with the Americans with Disabilities Act, and a new crosswalk at the "five points" intersection of La Brea Avenue, Stocker Street and

Overhill Drive.

"Everyone I speak with the Eastern Ridgeline Trail love it! I design and maintain the Kenneth Hahn Park Walk/Run Club website and have posted great pictures of the trail for park users to see. I visit the park four to five days a week to ... walk the ridges and the paths, and then end my walk with a workout. It's about health."

Many Department staff members worked very hard to bring this project to the community, and special thanks go to Hayden Sohm, Roy Williams, Jane I. Beesley, Francine Choi, Shawn McAdory, Jaheel Dixon, Dwight Ponder, Chester Kano, Dwight LaCroix, Daniel Abratte and Kevin Kane.

This exciting addition to the existing trail network at Kenneth Hahn State Recreation Area was made possible by a partnership between Chairman Ridley-Thomas' office, the Los Angeles County Chief Executive office, the Baldwin Hills Conservancy, the Department of Parks and Recreation and the Department of Public Works.

# FINDING A PLACE FOR THE PLAQUE

How a chance discovery led to a permanent home for a piece of baseball history at Jackie Robinson Park. **By Heather Larson** 

S adly, it is not an unfamiliar sight: heaps of miscellaneous rubbish lying on the side of the road. Old memories jumbled together with empty bottles, bits of paper and tattered clothing.

Knowing they are destined to wind up in a landfill, most of us think little of these seemingly random piles – other than seeing them as yet another reminder of why we should not litter.

These scenes are even more commonplace to those charged with keeping our neighborhoods clean. But when he happened to discover an item that clearly deserved a better fate than the refuse heap, one man with that responsibility – Los Angeles County Sanitation District employee Richard W. Caulkins – used his sleuthing skills to give that relic a second chance.

About two years ago, when Caulkins was making his rounds in Palmdale, he came across what he described as "a pile of trash, and it was really bad. It looked like an apartment had been cleaned out and dumped."

In that pile, he noticed a plaque bearing the logo of a Major League Baseball team, given to a man for contributing time and energy to the betterment of his community. The honoree: Sammie Haynes, a beloved baseball player who once played alongside such greats as Jackie Robinson and Satchel Paige. Bestowing the honor was the San Francisco Giants.

Haynes' name may not be instantly familiar to anyone but the most ardent fans of America's pastime, but from 1942-45 he was a star catcher for the Kansas City Monarchs of the Negro League.

Just two years before Robinson broke the color barrier and forged a path that Haynes was certainly talented enough to follow, his baseball career was cut tragically short by glaucoma – an affliction that would eventually leave him completely blind.

Rather than slow down, Haynes then dedicated his life to helping others by founding the International

Society of Athletes – an organization dedicated to providing support to former athletes who have fallen on hard times and require assistance with medical bills and other necessities.

Haynes, who died in 1997 at age 77, also performed volunteer work with the Special Olympics. His dedication to the community earned recognition from President Bill Clinton and others, including the Giants.

After researching Haynes' history, Caulkins was moved to find a proper home for the plaque. "His legacy doesn't deserve to have anything to do with a trash pile," he said. "His legacy deserves to be honored."

In his search for answers, Caulkins contacted the office of Los Angeles County Supervisor Michael D. Antonovich. An aide to the supervisor suggested that the plaque be donated to Jackie Robinson Park, located in Littlerock.

Today, the plaque has a place of honor at the park named for one of America's all-time heroes.

Said Peg Lee, Jackie Robinson Park Recreation Services Supervisor: "We are glad to ... have a place for it on the Jackie Robinson Park Wall of Fame."



or many in a group of young people who camped under the stars at Castaic Lake State Recreation Area in September and Santa Fe Dam Recreation Area the following month, the excursion was their very first overnight adventure in the outdoors. And what a forav into nature it was: In addition to sleeping in tents, participants learned about native flora and fauna during docent-led hikes, cooked their own food outdoors, learned about astronomy and much forward to each one of these more.

It was all part of Start Mentoring Outgoing Resourceful Environmental Stewards (S.M.O.R.E.S.) - a State of California Habitat Conservation Fund (HCF) grant-funded program of the Department of Parks and Recreation aimed at helping youth ages 4-17 establish a deeper connection to nature.

At each S.M.O.R.E.S session. there are approximately 150 youth participants - along with adult mentors and natural area leaders from the Department of Parks and Recreation – taking part in a variety of activities, including: birding, camping, astronomy, hands-on workshops in hiking and trail safety, fishing and much more. Among the campers, one of the most popular features are the live animal demonstrations.

Volunteers from Los Angeles County Natural Areas also assist with activities and mentoring - all focused on supplementing science and nature education by providing opportunities that are not available in a regular classroom setting.

"S.M.O.R.E.S. is a fantastic program, because it gives a great group of young people real, handson exposure to the wonders of the natural world – many for the very first time." said Natural Areas Administrator Kim Bosell. "We are excited to play a part in bringing this experience to them, and look events."
