# 1.0 Conditions of Payment

DTD will not accept payments through this Site from any party/individual who is not an authorized user of the credit/debit card or eCheck utilized for the payment of the fees. By submitting a payment through this Site, you certify that you meet these, and all other requirements outlined in these Terms of Payment. Capitalized terms used in these Terms of Payment shall have the meanings given to such term in the Terms of Use and/or Privacy & Security Notice, as applicable.

### 2.0 Credit/Debit Card Payment

Credit/debit card payments are limited to cards with Visa, MasterCard, Discover, and American Express logos. Your monthly card statement will reflect your payment amount, in its entirety, as one payment. The total payment will be labeled as "LACODTDDONATION".

## 3.0 eCheck Payment

eCheck payments are limited to U.S. business/corporate or personal checking accounts drawn on U.S.-based financial institutions. Your payment, in its entirety, will appear on your billing statement as one payment and will be labeled "LACODTDDONATION".

### 4.0 Payment Date

Your payment is deemed received after all of the following occurs: (1) you select the "SUBMIT" button for your payment, (2) we confirm the transaction, and (3) we provide you with a confirmation number via email.

### 5.0 Transaction Receipt

Payment is not deemed made until we provide you with an online confirmation number for such payment. You can email, download, or print a copy of the receipt page with your confirmation number for your records. In addition, you will receive an email confirmation of your payment if an email address has been provided. It is recommended that you check your email SPAM folder for our email. You can add the <a href="mailto:donotreply@fisgov.com">donotreply@fisgov.com</a> domain name to your Safe Senders List to ensure that you continue to receive our email in the future. We also recommend that you keep this

confirmation number available for reference to assist DTD personnel should you have questions related to your online payment.

## **6.0** Your Representations

Any notice or other type of information that is provided to you in connection with the ePay service, such as these Terms of Payment, the <u>Terms of Use</u>, <u>Privacy & Security Notice</u>, payment confirmations, amendments, and other payment information ("Communications"), may be sent to you electronically (i.e., by posting the information at this Site or by sending it to your email address). We will not be obligated to provide any Communications to you in paper form. If you do not agree to receive electronic communications, you agree not to use the ePay service and should select the "CANCEL" button now.

## **8.0** Minimum System Requirements

To use the ePay service, you will need a working connection to the Internet from a personal computer, tablet, or mobile device. The ePay service may not function properly when using Webenabled television. Your Internet browser must support TLS 1.2. You will also need either a connected printer to print Communications or sufficient hard drive space available to save the information. You must have your own Internet service provider (ISP), as we do not support and/or provide an ISP service.

## 9.0 Disclaimers Limitation of Liability

We offer the ePay service as a courtesy only. In addition to the disclaimer of warranties included in the <u>Terms of Use</u>, we assume no obligation to ensure that it is available for your use. There may be times when the ePay service is unavailable due to system maintenance, outages, or unavailability of Internet services.

In addition to the limitation of liability included in the <u>Terms of Use</u>, you agree that neither DTD nor the County of Los Angeles shall be subject to any liability related to the payment of fees for services using the ePay Service, including any amount of damages above the aggregate dollar amount paid by you for such services under these Terms of Payment.

## 10.0 Tax Information

Donations, contributions, or gifts to the County of Los Angeles or any of its departments are taxdeductible if they are for public purposes.
