NARRATIVE: DETECTIVES FROM THE LOS ANGELES COUNTY SHERIFF'S DEPARTMENT SPECIAL VICTIMS
BUREAU CONDUCTED AN INVESTIGATION INVOLVING SEXUAL MOLESTATION ALLEGATIONS BETWEEN FEMALE
STUDENTS ATTENDING COMPTON HIGH SCHOOL AND A TEACHER, SUSPECT OCANA.

INVESTIGATORS LEARNED THAT THE BROTHER OF ONE OF THE VICTIMS DISCOVERED
INAPPROPRIATE TEXT MESSAGES ON HIS SISTER'S CELL PHONE ORIGINATING FROM OCANA. THE BROTHER
BROUGHT THIS TO THE ATTENTION OF COMPTON HIGH SCHOOL PERSONNEL. FURTHER INVESTIGATION
RESULTED IN IDENTIFYING THREE FEMALE JUVENILE VICTIMS WHO REPORTED BEING SEXUALLY MOLESTED
BY SUSPECT OCANA IN HIS CLASSROOM.

ON APRIL 30, 2010, SUSPECT OCANA WAS ARRESTED WITHOUT INCIDENT. HE WAS TRANSPORTED
AND BOOKED AT WALNUT SHERIFF'S STATION AND IS BEING HELD ON \$390,000 BAIL.

THE LOS ANGELES DISTRICT ATTORNEY'S OFFICE HAS FILED FIVE FELONY COUNTS AND ONE
MISDEMEANOR COUNT OF VARIOUS SEXUAL MOLESTATION CRIMES AGAINST OCANA.

THE COMPTON UNIFIED SCHOOL DISTRICT PLACED OCANA ON PAID ADMINISTRATIVE LEAVE.
