PROBATION DEPARTMENT

The Commission will conduct routine inquiries and discussion on the topics listed below, and will take action, as necessary, such as receiving reports and other materials.

- 4. Quarterly update from the Probation Department on the Department's Reserve Program.
- 5. Department to provide successful living data on youth at Campus Kilpatrick.
- **6.** Report from the Probation Department explaining the rise in number of minors in Hope Centers in Juvenile Halls.
- 7. Updates requested from the Probation Department regarding items discussed at the December 14, 2017 Meeting.

- A. Discussion regarding a young man who told Commissioners that he had been confined in his room for three days and had not attended school. Chief Deputy Mitchell informed the Commissioners that there is an investigation into this matter. (PC requests and update regarding steps being taken to ensure that Hope Center kids are going to school and how progress is being assessed.)
- B. Discussion regarding the need to track the readiness of youth to return to his or her assigned house unit or any Specialized Supervision Plan forms. Per policy on Special Supervision Program, it requires a Director to review them routinely and to assess when a youth may be returned to their room. The Probation Department is revising the policy and must ensure the Special Supervision Program is being used appropriately. (PC requests an update.)
- C. The Commission expressed they wanted to reinstate the Hope Center. (PC requests an update.)
- D. The Probation Department has been working closely with DMH staff as they are a vital partner helping with de-escalating the issues and with coverage. The DMH clinicians play an extremely valuable role in helping to de-escalate issues for the youth. Probation is working with DMH to discuss the expectations of both Departments. (PC requests an update on this and how clinicians across the board are meeting agreed upon expectations?)
- E. Discussion regarding the frequency of pepper spray-use by staff. (PC requests an update on the use of pepper spray vs verbal, other de-escalation techniques?).
- F. The Probation Department is revising the behavior modification management program (BMP). (PC requests an update. Also, in addition to more board games and puzzles, youth have requested more programming, like the opportunities offered through Arts for Incarcerated Youth. Are more AIYN programs being brought into CJH?)
- G. Discussion regarding the Probation Department's current grievance process and their plans for the new grievance system the Probation Department plans to put in place. (PC requests an update on grievance process at CJH and throughout the system.)
- H. Discussion regarding the Department's commitment to training staff in trauma informed care. The Probation Department wants to make sure all superintendents, directors, and the leadership team are educated on trauma informed care so they can serve as coaches and mentors to the youth, and ensure they use community-based organizations in the juvenile halls. Probation has requested that Deputy Director Dominguez take the lead in helping institutionalize these requirements within the facilities and Deputy Director David Mitchell will be doing the same at the camps. (PC requests an update.)

- I. President Gardner inquired about the Specialized Program which is used when a youth cannot live in a large dorm environment or is having anger issues and cannot get along with others. Chief Deputy Mitchell stated that youth in the Specialized Supervised program are monitored and evaluated every 4 hours. The youth cited in the report was so angry he was involved in three fights within three days. Staff had to figure out what was triggering the youth's aggression and what type of skills to provide him with. (PC requests an update. Particularly, are these situations being handled differently now?)
- J. Chief McDonald stated that there is an accountability plan that will be presented to the Board of Supervisors and then the Probation Commission. (PC requests an update.)
- K. Discussion regarding coordination between Probation and DMH, and the use of a Memorandum of Understanding to improve the coordination of care. (PC requests an update.)
- L. Chief Mitchell will follow-up if CBOs are working with the youth at CJH. (PC requests an update.)
- M. Discussion regarding long-term goal to have an auditing system regarding security checks in the units. (PC requests an update.)
- N. Discussion regarding the training the Probation Department has accomplished for DBT staff and de-escalation techniques, and if there will be refresher trainings. (PC requests an update.)
- O. The Probation Department is working with the CEO's office to obtain funding for 40 hours of post training. (PC requests an update.)
- P. Discussion regarding in-depth analysis on the use of force policy. (PC requests an update. Particularly, the status of any analysis conducted and new policies on topic.)
