# 1.0 PURPOSE

The County of Los Angeles Probation Department (County) is issuing this Request for Information (RFI) to determine the extent of interest from qualified agencies in providing the services listed in Section 3.0.

This is a Request for Information (RFI) only. This RFI is issued solely for information and planning purposes. It does not constitute a Request for Proposals (RFP) or a promise to issue a RFP in the future. This RFI does not commit the County to contract for any supply or service whatsoever. The County will not pay for any information or administrative cost incurred in response to this RFI. The County reserves the right, at its sole discretion, to invite any responding vendors to this RFI to provide a non-competitive presentation. The presentation is intended for information gathering purposes only as part of this RFI process.

# 2.0 BACKGROUND

The Postrelease Community Supervision Act of 2011 was signed into law on April 4, 2011. It created two new types of adult community supervision - postrelease release community supervision and split sentence supervision (mandatory supervision). The Postrelease Community Supervision Act of 2011 also requires that the County's postrelease supervision strategy be consistent with evidence-based practices to reduce recidivism (Penal Code 3450).

Evidence Based Practice (EBP) research has identified eight criminogenic needs that contribute to criminal offending, one of which is family and marital relations. As a criminogenic need, the family/marital domain is often characterized by stress and conflict in relationships with family and significant others.

Strong relations with pro-social family are important to reducing offending behavior and substance use family ties are believed to reduce offending by serving as a protective factor to insulate from criminal influences, as well as provide emotional support and facilitate the change process.

The purpose of the treatment services described in Section 3.0 is to provide evidence-based programming to address the Family/Marital criminogenic need.

# 3.0 SERVICE DESCRIPTIONS

#### 3.1 <u>Couples Therapy</u>

The purpose of couple's therapy is to improve the dyadic relationship with the overarching goal of reducing future criminal behaviors by reducing conflict in the relationship. The service should be a therapeutic service for couples that uses proven, EBP and interventions designed to reduce conflict, enhance communication, and identify and assist in solving the couple's problems. The service shall include an evidence-based mechanism for evaluating the effectiveness of the service. This shall include specific outcomes, performance indicators and supporting measures. The proposed service should include a recommended treatment dosage and duration (e.g. 13 sessions over a 6-month referral period) and length of each session (e.g. 60 minutes). There should be no more than one couple per session. Providing Couples Therapy in Spanish is desirable but not required.

## 3.2 Family Therapy

The purpose of family therapy is to improve family functioning with the overarching goal of reducing future criminal behavior by reducing family conflict and building positive, supportive relationships.

The service should be therapeutic for families that uses proven, EBP and interventions designed to reduce family conflict, enhance communication within the family, identify and assist in solving family problems, and build pro-social family relationships. The proposed service shall include an evidence-based mechanism for evaluating the effectiveness of the service. This shall include specific outcomes, performance indicators and supporting measures. The proposed service should include a recommended treatment dosage and duration (e.g. 13 sessions over a 6month referral period) and length of each treatment session (e.g. 60 There should be no more than one family per session. minutes). Providing Family therapy in Spanish is desirable but not required.

#### 3.3 Individual Counseling

The purpose of individual counseling is to focus on the specific risk factors and personal factors (including trauma, loss and grief) that are contributing to family conflict.

The proposed service should use proven, EBP and interventions designed to reduce family/marital conflict, enhance communication within the family, identify and assist in solving family problems, improve parental involvement and skills, or build pro-social family relationships. The proposed service shall include an evidence-based mechanism for evaluating the effectiveness of the service. This shall include specific outcomes, performance indicators and supporting measures. The proposed service should include a recommended treatment dosage and duration (e.g. 13 sessions over a 6-month referral period) and length of each treatment session (e.g. 60 minutes). There shall be no more than one client per session. Providing Individual counselling in Spanish is desirable but not required.

#### 3.4 <u>Parenting Classes</u>

The purpose of parenting classes is to teach the participants and their coparent how to effectively parent their children with an emphasis on reducing family conflict and reducing the children's involvement in the criminal justice system.

The proposed service should be a manualized parenting class program that uses a proven, evidence-based model and focuses on cognitivebehavioural and parent management skills development. The proposed service shall include an evidence-based mechanism for evaluating the effectiveness of the service. This shall include specific outcomes, performance indicators and supporting measures. The program is subject to County approval. The proposed service should include a recommended service dosage and duration (e.g. 12 hours of classes over a 3-month referral period). Providing Parenting classes in Spanish is desirable but not required.

#### 3.5 <u>Mediation Services</u>

The purpose of the mediation services is to work with participants and their families, co-parents, in-laws, or significant others that are involved in a dispute to identify the issues, reduce misunderstandings, clarify priorities, find points of agreement, explore new areas of compromise, and negotiate an amicable resolution and written agreement.

The proposed service shall use proven, evidence-based practices and interventions designed to reduce family/marital conflict, enhance communication within the family, identify and assist in solving family problems, improve parental involvement and skills, or build pro-social family relationships. The proposed service shall include an evidence-based mechanism for evaluating the effectiveness of the service. This shall include specific outcomes, performance indicators and supporting measures. The proposed service should include recommended dosage and duration (6 hours of services over 3-month referral period). Providing Mediation services in Spanish is desirable but not required.

- 2. Contact name, title, business and mailing addresses, telephone number, and email address;
- 3. Original signature of the authorized Officer of the agency.

#### 4.6 Notice to Respondents Regarding the Public Records Act
