

#### <u>ADMINISTRATIVE MATTERS</u>

Commission President Joe Gardner welcomed all and called the meeting to order at 10:10 A.M. President Gardner informed the Commissioners and all present that the meeting was being recorded and asked that all identify themselves prior to making anv statements.

6. Response and report from the Probation Department on training, including the number of new hires going through or graduating from training in 2018 compared with the number of those staff still on the job as of April 2019.

7. Follow-up report from the Probation Department regarding specifics on programming in camps and halls such as schedules.

The Commission made the following inquiries regarding services/programs offered in camps and halls:

- What tools are in places to measure program outcomes?
   Dalila Alcantara, Bureau Chief informed the Commission that there is currently a unit being created to conduct assessments and follow-ups on programs.
  - Who conducts college courses?
     Jocelyn Roman, Probation Director answered (for the halls) East Los Angeles college and online courses.
  - What are the deciding factors in determining which youth receive services/programs?
     Director Roman provided factors such as availability of programs, staff rotation, and volume of participants request a specific program/service. There are also services for youth on 1:1 supervision.
  - Are all college courses pre-requisites or life skills?
     Bureau Chief Alcantara confirmed college pre-requisite college courses are available.
  - How does Probation provide adequate programs with current staffing issue?
     Director Roman stated that a new class of Detention Services Officers and Group Night Supervisors will commence in December.
  - The Commission inquired about Camp Kilpatrick's limited sport programs.
     Bureau Chief Alcantara informed the Commission that the youth are now at Challenger and have more sport programs available.
  - Does Probation seek services/programs on their own and who is responsible for linking the minors to each service/program?
    Director Roman informed the Commission that Probation is proactive in seeking services/programs and conducts monthly meetings to vet potential services/programs. For the majority, field Deputy Probation Officers in collaboration with the courts are the parties responsible for linking services/programs with the youth.
  - The Commission recognized the first youth to receive an Associate's Degree.

However, what happens to youths in the R.S. program and what happens to their services/programs, once they transfer to camp?

Director Rojas indicated there are options available, such as; conducting MDTs and/or a request is made to the court to allow the youth to remain in the halls to continue with the service/program. Also, the camp will attempt to match a similar service/program.

- When will the youth of Kilpatrick be returning and how many?
   Bureau Chief Alcantara inform the Commission that 20-30 youth should return to camp by late October.
- The Commission advised Probation to set up protocols for CBOs. One of the protocols should be to allow services/programs to be transferred with the youth; CBO training should mirror Probation staff training.
- Why did Camp Kilpatrick close and why has there been a delay in reopening it?
   Bureau Chief Alcantara informed the Commission that the issue is a result from a fire which caused water damaged.
- The Commission expressed concern about the limited availability of Anti-gang services/programs.

Director Roman explained the issue is trying to provide a wide range of services/programs that interest most of the youth. These services/programs are voluntary and cannot be forced on youth.

**Action Item(s):** Jocelyn Roman to provide the Commission with a two-week snap shot of programs offered at Central Juvenile Hall to include point of contact information of the program lead, number of youth who attended the program, and an updated list of programs offered.

Probation to provide a catalog of all college course offered to the youth.

Director Roman to provide Commission with status of two filed youth grievances.

Probation to provide additional information regarding Individual Family Therapy offered in camps.

The Commission will conduct routine inquiries and discussion on the topics listed above, and will take action, as necessary, such as receiving reports and other materials.

#### V. COMMISSIONER REPORTS AND UPDATES

Commissioner Meredith reported problems with drugs and electronic pens being delivered to camps via drones.

The Commission also discussed sexual assaults and battery on female staff and the failure to report or act for fear on possible repercussions. The Commission referred to the high volume of staff on FMLA and the tone of the youth being in control. Bureau Chief, Dalila Alcantara, indicated that security and safety of staff is paramount and that the department is actively working with labor partners to find resolutions.

Commissioner Gardner reminded the Commission to provide formal reports addressing any inspection concerns by the first week of November.
