- 4. Continuation of the Department's November 14, 2019 presentation regarding the Transformative Career Institute to be opened at the former site of Camp Gonzales to answer the following:
 - Will Probation be the County Department responsible for overseeing this new multi-million-dollar program?
 - Will this program involve young adults not subject to Probation jurisdiction?
 - What will be the cost per participant?
 - How much of that will come from Probation funds?
 - What accounts will those funds come from?
 - What are the committed sources of funding and in what amounts?
 - What are the criteria for enrollment?
 - What is the background, expertise, and track record of the CBO in charge running this residential treatment program? (Is there a CBO identified to run the facility day to day? Who is it?
 - What will the staffing levels be for 30 adults per 6-month session?
 - What are the identified outcomes? How will data be tracked?

The Commission provided clarification of questions regarding item #4. This item was continued.

- 5. Update from the Probation Department regarding minors evacuated from Barry J. Nidorf Juvenile Hall on October 10, 2019 due to major wildfire. Questions to include:
 - When will minors be transported from Los Padrinos site back to Barry J. Nidorf Juvenile Hall,
 - Are minors receiving recreation, education and other programming?

Youth/Staff are scheduled to return to Barry J. Nidorf Juvenile Hall on December 14, 2019. The facility has been renovated with paint, improved decontamination units, and various other improvements. Los Padrinos (LP) presented challenges due to being repurposed but was up and running within 24 hours.

Probation stated that theories for success while staff/youth were relocated at LP are more space, softer look/feel of a more rehabilitative facility, a reset at a new facility, youth felt cared for, and an increase in staffing ratios.
