#### **ADMINISTRATIVE MATTERS**

Commission President Joe Gardner welcomed all and called the meeting to order. President Gardner announced that meetings are recorded and asked that everyone identify themselves prior to addressing the Commission.

#### **APPROVAL OF MINUTES**

3. January 23, 2020 minutes were approved. February 13, 2020 minutes were tabled.

#### III. PROBATION DEPARTMENT

Response to request for information from the Probation Department regarding 4. increase in the number of minors sent to H.O.P.E. Centers including explanation for youth who have extended stays.

> Mr. Thomas Faust introduced himself as the Acting Chief Deputy Juvenile, while Ms. Shelia Mitchell is on leave.

Jennifer Kaufman, Residential Treatment Services Bureau (RTSB) provided an update on the 2019 H.O.P.E. Center referrals and the reasons for extended stays. She attributed the increase in referrals from the third quarter (July, August, and September 2019) to the consolidation of camps. She reported the referrals stabilized in the fourth quarter.

Ms. Kaufman stated the following reasons a youth might have an extended stay:

- Youth being admitted after hours
- Youth waiting for outside services (i.e. Mental Health)
- Youth de-escalation
- Conducting Specialized Supervision Plan (SSP)
- Youth refusing to return to their assigned room

The Commission followed up with questions, which were answered as follows:

- Why would a youth choose to stay in the H.O.P.E. Center?
  - Youth might prefer smaller group settings.
  - To avoid future conflicts: either to ensure being released on time or feel safe.
  - Unable to control themselves
- Can a youth request to stay in the H.O.P.E. Center?
  - o No, they are placed there and then choose not to return to their room.
- Does the vouth receive Educational Programs while in the H.O.P.E. Center?
  - Yes, they still go to school or the instructor might conduct the lesson at the H.O.P.E Center. The youth also receive recreational time.
- Does the youth receive extra attention in the H.O.P.E. Center?
  - Yes, Mental Health conducts a behavioral chain analyses of each youth.
- Does Probation know the justifications the youth chooses to stay in the H.O.P.E. Center?
  - Yes, Probation provided the top five reason on the 2019 report handout.
- How is the H.O.P.E. Center staffed?
  - A dedicated H.O.P.E. Center Supervisor has been hired and there is a posting for a second.

The Commission expressed concerns about the camp closures attributing to issues facing Probation Camps and Juvenile Halls.

Mr. Alex Nieto, Superintendent at Central Juvenile Hall (CJH), informed the Commission that the increase of referrals to the H.O.P.E. Center in the third quarter is due to the closure of Los Pardrinos Juvenile Hall (LP). Since the closure of LP, CJH intakes in the third quarter were 120-130. The increase in the fourth quarter is due to the Saddler Ridge fire; however, the number has decreased since Barry J. Nidorf started receiving intakes.

Mr. Nieto also stated the same reasons as Ms. Kaufman for youth extended stays in the H.O.P.E. Center.

The Commission inquired when CJH would be accepting inspections conducted by the Commission. Mr. Dominguez, couldn't give a specific date due to current updates/renovations being done at CHJ.

The Commission inquired about the L.A. model being implemented as far as at the camps. Mr. Dominguez stated the challenges on following the model when not all facilities are the same. Mr. Faust also mentioned, for the L.A. model to be successful, accountability needs to be enforced.

The Commission suggested that Probation to contact Mark Steward, creator and consultant of the L.A. Model to get further assistance on training and implementation in the camps. Mr. Faust, assured the Commission that he is very familiar with the model and he and the Interim Chief are working diligently on implementation.

Mr. Eduardo Mundo, former Probation employee, sympathized with today's Probation camp staff and the challenges they face. He also expressed his concern for the placement of youth once they are released from camp.

**6.** Commissioner Gardner circulated the Commissioner Inspection sign up list; the deadline will be November 12, 2020. Commission Gardner encouraged female Commissioners to sign up for Camp Scott (female facility) for broader access.

### VI. COMMISSIONER REPORTS AND UPDATES

7. Report-back from Commissioner Herbon regarding acquiring schedule of upcoming training.

Adam Bettino, Bureau Chief for Professional Accountability Bureau is currently working on compiling a comprehensive training schedule with all operation. The Commission is requested a schedule of CORE classes, entry level classes, physical intervention for RTSB and DSB.

The Commission expressed concerned about paramedics entering Central Juvenile hall to attend to a teacher who had been assaulted by a violent developmentally disabled youth. Commissioner Herbon commended Probation staff for being professional and escalating the situation. Commissioner Gardner would like to create a case study around the incident to better understand the Department's process.

9. Response from Probation Department regarding Commissioner Hebron's inspection of Camp Paige submitted February 13, 2020.

Commissioner Gardner reminded the Commission that the Department has 30 days to respond.

Commissioner Yamashiro would like the Departments contingency plan on addressing the Coronavirus. He also offered the Los Angeles Bar Association (7<sup>th</sup> and 110 freeway) to host Probation Commission meetings.
