Tom Faust, Acting Chief Deputy, Probation Department, introduced agenda item V a and introduced co-presenters, Kim Bowman, FUSE Executive Advisor, and Mercy Santoro, LACO Parks and Recreation. **Audio Time Stamp: 7:46-8:24 57:42**

Mercy Santoro, LACO Parks and Recreation, thanked everyone for the opportunity to serve as subcommittee chair and acknowledged the subcommittee members. The subcommittee held 6 meetings, totaling 16 hours to deliberation and review for over 60 proposals. The subcommittee was well represented by various Board offices, community-based organizations and county departments. She acknowledged the hard work of Kim Bowman as he provided expertise in the process. She also acknowledged Probation for administrative support. As part of her high-level review, she stated their main consideration was continuity of services to youth and families. When they engaged their work, they looked at several priorities, and many were derived from the JCCC-CAC surveys: the survey results showed the need or continued focus on public health and homelessness and providing mental health support. There was an expressed priority to review the provision of services in Antelope Valley and South Los Angeles. Those considerations informed their thinking. There was a great deal of work as a result of analyzing carry-over funding. There were several setbacks regarding administering programs, including but not limited to, the uncertainties caused by COVID-19 impacts. The subcommittee's work on the CMJJP included altering the definition of youth to "at-promise" rather than "at-risk." While the federal definition remained unchanged, the subcommittee wanted to be forward thinking for youth regarding their strength and resiliency. She thanked Patricia Soung and Luis Rodriguez for their work and review of the Mission Statement. They had the concept to bring forward the following to the forefront of their thinking when they updated the Mission Statement. They wanted it to reflect a statement of racial equity that brings forward the realities of the current confrontation with structural racism, and thus it made their mission relevant to current times. The subcommittee will continue to work with data from RAND that will help them look at gaps, best practices, to more effectively serve young people. They reviewed the CMJJP calendar and decisions

were made to provide additional time for JJCC members to review the information until the next JJCC meeting prior to the voting on funding. She later added that the subcommittee members each received between 5-7 proposals along with a partner reviewer and all subcommittee members reviewed the proposals with a thorough vetting reviewed process. She indicated line item 55 came up among the group, as an emergent needs fund for spring of 2021 because of the unknowns. so there would be continuity of services. They also looked at their strengths on collaboration of services. She stated within the CMJJP, the spirit of collaboration is embedded throughout their work. *Audio Time Stamp: 8:25-15:31, 23:41-24:05, 45:06-49:08*

Kim Bowman, FUSE Executive Advisor, began by thanking Mercy Santoro. He indicated that the Final Report was 86 pages and they were able to deliver it to the JJCC by November 25, 2020, as promised. He stated the subcommittee was formed by a JJCC Resolution on August 26, 2020. The Resolution indicated it would include a proportional representation of JJCC Members and must remain below quorum according to the Brown Act rules. To the extent possible, they wanted to ensure that it was a diverse group of voices representing governmental partners, community partners and providers. There were two recommendations reached by the subcommittee. The first was to adopt the Fiscal Year (FY) 2021-2022 CMJJP. The second was to adopt the FY 2021-2022 JJCPA Funding Allocations recommendations. The subcommittee recommendation was to have the funding allocations be heard at the January 14, 2021 JJCC Meeting. While there was no motion, they would be able to ask the subcommittee questions.

The CMJJP document in the report is the same document that is agendized. The framework for the CMJJP remained the same, however, the timeline was changed. In summer, the JJCC-CAC will produce a survey to allow the community to provide input and will remain open for six weeks, with a closing date of September 1, 2021. Governmental partners will have the same opportunity from mid-July until September 1, 2021 to submit proposals and requests. There is a distinction between governmental partners and those subject to specific board contracts. They are treated one way under the law, because of county contracting rules. General community input is treated a different way. He and Mercy discussed ideas about how to operationalize the process by having some electronic automation rather than the current style of relying on emails and spreadsheets. He stated the timeline is similar: July we ask for input, and September is when everything is due, because at the end of August, the Subcommittee is formed. From September through November the Subcommittee will work to update the plan and work on the funding allocations. They decided that January 2022

would be when the funding allocation would be considered. They also changed the timeline this year to have two different JJCC meetings. The decision was to have one meeting for the CMJJP and to give everyone six weeks to review information and then have the vote in the January 2021 meeting. He covered the updates made to the CMJJP and he thanked RAND for their assistance with data. He covered the Heat Map that is produced for the plan annually (by Probation), with very little changes from year to year.

The funding allocation recommendations were provided in two views. The first view (in color) and was by funding type, so the different colors cover the type of buckets and he covered the different columns by name and colors. He indicated if you add to "A" "B" and "C" it provided the total. For all who submitted proposals, the following question was posed: to indicate how many youth would they be able to serve by SPA and by Supervisorial District. The subcommittee considered the nature of the population, capacity building and cost of each youth served. He covered the methodology for how they arrived at their funding allocation recommendations. They used last year's funding as a baseline. They considered which programs were effective, and therefore should continue; which programs, programmatically they may not want to continue; and what amount do we think they will carry forward. The question of how much they would carry forward, and due to the pandemic in 2020, was an incredibly difficult question to answer. He stated that they did not expect that they "nailed this." They asked providers to provide estimated expenditures for the Fiscal Year and estimated carryover. They could still spend it next year with the carry-over. He stated the JJCC received proposals for approximately \$25 million more than the amount of funding available. He stated the JJCC members now had the written recommendations and the spreadsheets. The goal was to maintain continuity of services to the most high-risk/high-need, areas/populations, that would maximize the efficiency of funds. He stated the JJCC would not be voting on this date, however, they could review the subcommittee recommendations, and with the subcommittee in attendance, they could ask questions. If the Subcommittee let JJCC know the questions during the meeting of December 3, 2020, they would give the subcommittee approximately 6 weeks to provide a response to make it a part of the presentation during the January 14, 2021 JJCC meeting. In January 2021, when each individual paragraph is considered for adoption, there will be a slide show and Rules R discussion, similar to last year. This way the JJCC would be able to make the best use of the six weeks of time. He stated it is very difficult to make the changes during the meeting. The subcommittee asked that if the JJCC members had ideas about what they wanted handled differently, that it would be best to prepare
