SB 823 Overview

- Signed by Governor Newsom on September 30, 2020
- As of July 1, 2021, prohibits further commitment of youth to DJJ
- Section 1991 includes the allocation of funds from the State to the General Fund for distribution, as shown below and listed in SB 823 1991(a)(1-4)

1991(a)(1)	FY 2021-22	\$39,949,000.00	Appropriated to General Fund
1991(a)(1)	FY 2022-23	\$118,339,000.00	Appropriated to General Fund
1991(a)(1)	FY 2023-24	\$192,037,000.00	Appropriated to General Fund
1991(a)(1)	FY 2024-25	\$208,800,000.00	Appropriated to General Fund

SB 823 Plan Process

- JJCC Juvenile Justice Realignment Block Grant (JJRBG) Ad-Hoc Subcommittee
 - SB 823 1995 (a) - To be eligible for funding, a Subcommittee of the JJCC shall be created to develop a plan describing the facilities, programs, placements, services, supervision and reentry strategies needed to provide appropriate rehabilitation and supervision services for the target population
 - SB 823 1995 (b) Composition of Subcommittee members
 - JJCC adopted the Resolution to create the JJRBG Ad-Hoc Subcommittee (January 14, 2021)

SB 823 Plan Process

- Section 1995 (a)-(g)
 - Description of target population, facilities, programs, placements, services, supervision and reentry strategies
 - Description of how funds will be applied to address needs/development of realigned youth, data to be collected and how the plan will incentivize or facilitate the retention of realigned youth within the jurisdiction and rehabilitative foundation of the juvenile justice system in lieu of transfers of realigned youth into the adult criminal justice system
 - Description of any regional agreements or arrangements to be supported by the block grant allocation
 - Description of how data will be collected on youth served and outcomes for youth served, including outcome measures that will be utilized to measure or determine the results of programs and interventions supported by block grant funds

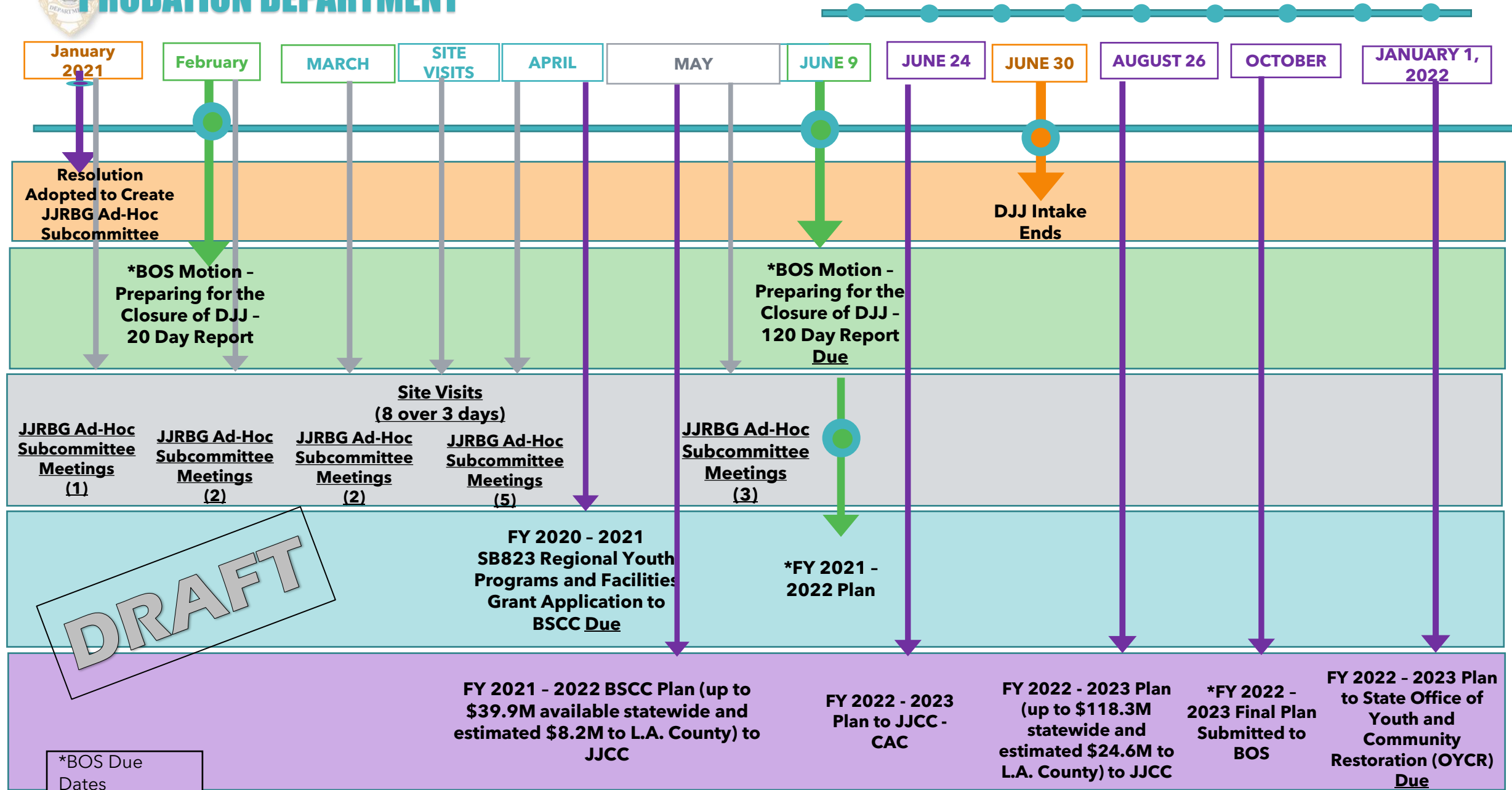
