	Answer	One contract award
2.	Question	When does the Probation Department anticipate completing its evaluation and notifying respondents of its recommended awardee(s)?
	Answer	There is no specific date at this time. Agencies will be notified once all proposals are evaluated.
3.	Question	If we are an incumbent, can the Probation Department be used as a reference?
	Answer	Yes.
4.	Question	Regarding the fingerprinting requirement on Page, 10 Section 4.5.1.1 - will the Probation Department be administering the fingerprinting of temporary personnel, and does the Probation Department have an ORI code? Or are vendors required to fingerprint temporary personnel on their own?
	Answer	Yes. Probation will administer the fingerprinting.
