Housing such criminals and serious offenders so close to so many amazing people and families makes absolutely zero sense to me. There are many schools in the area as well which also would negatively affect the safety of our future. My number one priority is to protect my family and keep them from harms way. If these camps are approved, our nice safe community will be completely ruined.

Please find it in your heart to NOT place these serious offenders near me and my family and all the other nice families that continue to live and thrive in this area.

I have lived in Saugus, right by the probation camp for over 49 years. Any kind of a higher security camp right in the middle of homes, schools, families, & were children play is just simply unacceptable. A more reasonable location like in the Mojave desert is a must. This is just a bad place to do this

8. Kenneth A. Anaya and Dawn M. Anaya

As the work of your Subcommittee continues to recommend a permanent location for the male "serious offender" population, we continue to stress to all of you that local residents and their families are equally important as the "serious offenders".

The County of Los Angeles, County Probation Department and your Subcommittee have not sought input from potentially impacted local residents and businesses. This lack of transparency is disheartening to say the least and loses the trust of the public. We request an "official" notification mailing to potentially impacted residents and businesses, providing at least 15 days written notice before the Subcommittee's recommendation is scheduled before the LA County Board of Supervisors.

"Remoteness from communities" is cited as an ideal factor to achieve the vision for rehabilitation, the location of Camps Scott and Scudder are obviously not remote from communities. The location is literally in feet of existing residential neighborhoods, a future development of 375 homes adjacent to the Camps, a church, and a public transit stop used mostly by children on their way to and from school. The area is a fire hazard zone with a history of evacuations and potential flooding. It is also rundown and cannot adequately house a serious offender population without a significant amount of money in renovations.

The Youth Justice Reimagined Report identifies the DJJ Transition Team agreed to focus on Campus Kilpatrick, and Camps Gonzales and Kirby as the most suitable locations. A minimum \$45 million has already been expended for Campus Kilpatrick to implement the "LA Model". What makes no sense, is how Camps Scott and Scudder were recommended as a permanent location to the LA County Board of Supervisors, especially as the ideal factor of "remoteness from communities" is not adhered to.

We **strongly oppose** the reconfiguration of Camps Scott and Scudder as a permanent location for the "serious offender" population. May we suggest the sale of Camps Scott and Scudder, with the revenue to be equally divided towards a permanent serious offender location and Victim Services Programs.

I have teenage children living in my home less than 1 mile from this camp. A prison camp located in the middle of residents, schools and parks is unacceptable. How will my children or myself feel safe in this neighborhood with a maximum security prison housing violent criminals? We won't! Our neighborhood has the power shut off constantly due to wind or fire danger. They are building over 300 new homes in the lot adjacent to the camp. Currently, this is at a location that is on a 2 lane road. It literally empties right onto my street where I live. With all of the open space and vacant land in other areas not located in a neighborhood, why would you house violent criminals here. The property is not up to code and will cost a fortune to update it. How about you move it out to the middle of nowhere and not next to me or my kids! A more reasonable location is a must!

Stop this now!

The photo above is the proximity of Camps and Scudder to a large and continuing area of homes. This is not the place to open a jail! I don't disagree that minors should not be in jail with adults (depending on their crime and age), however, this is NOT a safe space for them or families with children. On the other side of this photo is an active Horse Riding School: just a few feet from the camps' borders. As you can see the mountains are all around us (a fire threat) and the street is narrow. Exiting from the camp on the left (where the Riding school is) goes straight into the Angeles National Forest. Turn right and it goes straight into residential areas and parks and schools.

You have not been transparent with the citizens of Santa Clarita. We have asked questions and we have been shouting into the wind! As the public, who pay our taxes to fund your projects we have a right to know what you intend! Please, give us the respect that we deserve!!!!!

I am writing in response to the detention center on Bouquet housing "serious offenders". I have lived the the Bouquet Canyon Estates for at least 30 years. It has been a safe neighborhood, somewhat of a hidden gem. If a prison facility were to open in this area it would create an unsafe environment. The detention center is located in close proximity to homes, and elementary schools. There is also no infrastructure for the increased amount of traffic on Bouquet, Many of my neighbors fear that their property values would decrease. After all, would you like to live across fro a prison? There are other facilities in which these offenders can be housed that are vacant inLos Angeles County which are not in such close proximity to neighborhoods and schools. Pleaseconsider this when deciding on this location.

You have taken our trust & good faith and have tarnished your reputation, by considering Camp Scott.

Once you saw its location you should have imidately understood that it's not reasonable, ethical, or responsible to your constituents, steakholders, & community to put violent criminals across the street from homes.

Vote NO on Camp Scott.

My husband and I immigrated to this wonderful country to work hard in search of the American dream. There are a lot of negative things that one escapes from when moving out from your country, which are crime, violence, injustice, insecurity, robbery, corrupted politics and more. On many occasions we were victims of these crimes so you can imagine how in danger we feel with the new proposed prison camp.

It is not acceptable that the plan is to house murderers and rapists in this neighborhood, we CANT accept this and cant have these individuals in the middle of our one family private residences area, nor close to our schools, daycares, playgrounds, our kids! THIS IS NOT ACCEPTABLE!

With this we will no longer feel safe, we won't be able to go for walks as a family, or go for my routine runs, or let my kids play out on the sidewalk being so close to this maximum security prison with high profile criminals.

We can not accept this, not in our neighborhood. I can't even imagine the fear that I will feel when we get the power shut off whenever there are high winds, and this happens often. This is terrible, and to think that these criminals would be just steps from my door!

Why can't the State locate these individuals somewhere else, far from a family neighborhood, somewhere isolated and rural, the middle of the desert, not in Santa Clarita, not on my street where there are so many kids, where my kids live!

This facility was not even built for this purpose, why is the state or city allowing this now!

This community deserves better, we demand better. Don't move/bring criminals close to our kids!

Please stop this from happening! If you are a parent of a child, please put yourself in our shoes and stop this!

Unfortunately, I was unable to attend today's meeting regarding the agenda item or items for relocation of serious juvenile offenders being relocated to Camps Scott and Scudder in Saugus.

I am writing to you to express my dismay and concern about the intention of putting violent juvenile offenders into the existing Scott and Scudder Camp facilities in Saugus. These facilities are adjacent to family neighborhoods that have historically been very safe, low crime rate areas. These camps are not the right place to move them and you are risking everyone's safety and peace of mind that live here, not to mention the effect it will have on our property values.

I have been a resident of one of these neighborhoods for 26 years and moved here strictly due to the safe reputation of this city and area. The residents of this area should not have to live in fear of violent juvenile offenders and their cronies coming into our neighborhood where our children regularly walk to school and play outside. The camps are literally only a mile from my house. The area right next to them is going to be developed and there will be homes right up to the property line of the camps. Moving these violent juvenile offenders here will have dire consequences for everyone in this part of the city.

How could you possibly even consider voting to have these convicted criminals moved here? Obviously, you aren't the one who would be living down the street from them, but we are and you need to do the right thing by finding more appropriate facilities to house them.

Being that this potential move was not communicated to the public shows that the Division of Juvenile Justice Subcommittee knows it's a bad move and are trying to get this done before the public becomes aware of it.

At the time of sending this e-mail, the 15 e-mailed written public comments acknowledged in the audio recording of the September 16th meeting are **NOT** posted on the JJCC website.

This is a change in established practice as e-mailed written public comments from all other meetings are posted. It shouldn't matter if the e-mailed public comments are in favor or opposition. What matters is transparency and consistency. Doing so provides the full information for those who access the meeting records on the JJCC website.
