One of the event highlights was the Mobile Covid-19 Vaccine Clinic. Vaccines were made available to clients, staff, and residents. "We requested, and Public Health provided medical professionals and 100 doses of the Pfizer Covid-19 vaccine. We wanted to have enough for anyone that wanted to be vaccinated, whether it be clients, folks in the neighborhood, or staff that are still in need," shared Director Probasco. Several attendees took advantage of the opportunity and decided to get vaccinated while attending the event.

According to Director Probasco, the Rio Hondo Area Office endeavors to host a resource fair annually, with the next event happening in about seven months. "It's about doing good probation work. We've been closed due to Covid for over a year, and this was a great way to reopen our office. We want to let our clients know we are back, we are open, and ask them what is it that they need."
