Mercy Santoro, LACO Parks and Recreation, JJCC-CMJJP Ad-Hoc Subcommittee Co-Chair, covered the Rules of the Road. During the presentation, the Rules of the Road were shown on screen. She stated the Conflict of Interest rules apply and indicated JJCC members should be thoughtful about recommendations for funding. If the JJCC representative is a county department, it does not present a conflict of interest. If you are a JJCC member affiliated with a listed program, you will have to determine how those rules apply to you. The CMJJP Ad-Hoc Subcommittee's work was a two-part mission: to complete the CMJJP and to bring forth the recommended funding allocations. Should there be surface issues identified by a JJCC Member, it was requested that the member provide solutions along with the identified issues. To ensure deliverables, they would need to remain mission-focused on the work before them. c. FY 2022-2023 JJCPA Funding Allocations Recommended by the JJCC-CMJJP Ad-Hoc Subcommittee.

Adam Bettino, Chief Deputy, Probation Department, introduced Mercy Santoro LACO Parks and Recreation, JJCC-CMJJP Ad-Hoc Subcommittee's Co-Chair, to provide the presentation. He expressed his appreciation for the amount and depth of her work and indicated how much her work was appreciated. *Audio Time Stamp: 1:05:39-1:06:10*

Mercy Santoro, LACO Parks and Recreation, JJCC-CMJJP Ad-Hoc Subcommittee Co-Chair, indicated she would make a recommendation at the conclusion of her presentation regarding the error in the Agenda regarding VI c number 37. She began her presentation by acknowledging the 10 Ad-Hoc Subcommittee members that represented both Permanent and Non-Permanent JJCC membership and thanked them for their service. During her presentation, the JJCC-CMJJP Ad-Hoc Subcommittee membership and meeting dates were shown on screen. A considerable amount of work was completed on the CMJJP to arrive at a more transparent and accountable process around funding, evaluation, and reporting. The findings and the recommendations from the CMJJP were utilized to guide the funding allocations for both base and growth funds. She reminded everyone that a JJCC-CMJJP Ad-Hoc Subcommittee presentation was provided during the December 3, 2021, JJCC meeting, and the presentation was also reflected in the December 3, 2021, JJCC Meeting Minutes.

As an addition to the funding request application process, the agencies were asked to identify the continuum category for which the program(s) fulfilled. The change occurred in the Ad-Hoc Subcommittee process to be more transparent and as a commitment towards better evaluation and results. Due to the process change, there is a marked difference regarding the continuum category percentages when compared to prior years. In prior years, the Ad-Hoc Subcommittee and staff provided the categories. Therefore, the continuum categories' percentages are different this year by having the agency provide the information. Upon review, 12 out of 44 agencies selected more than one (1) continuum category.

She stated the significant amount of carry-over funding and the associated challenges and the range of realities faced by agencies was attributed to COVID-19. The funding allocation subtotal amounted to \$88,435,339.78. Additionally, she noted that the total amount of funding requests received was over the amount of funding available (overage amount of \$17,700,000.00). Base fund allocations are a stable funding amount that remains consistent at \$27,500,000.00. It was important to note that many agencies face increased staff and operating costs and some agencies attempted to capture those operating costs in their requested funding amounts. However, the funding allocation amount does not keep pace with operating costs. Therefore, those types of considerations

could not be included. Regarding growth fund allocations, the largest growth fund allocations included: ODR/OYDD (\$4.05 mil), Public Private Partnership (P/PP) grant making (\$3 mil), LACOE (\$1.5 mil) and P/PP Capacity Building (\$1.5 mil).

The Ad-Hoc Subcommittee spent a significant amount of time reviewing carry-over. They requested that agencies provide the percentage of funding that was dedicated to CBOs. It was important to continue to recognize mental health needs, housing needs and geographic needs of the community. It was also very important to maintain continuity of services and recognizing the shift in landscape due to multiple County Initiatives. She stated they wanted to balance a system that had been built out to provide a high-level of collaboration between funded organizations so youth and families may safely navigate and access them. She concluded her presentation on behalf of the Ad-Hoc Subcommittee. *Audio Time Stamp: 1:06:34 -1:25:40*
