



I was very shaken, and he kept reassuring me that things would be fine, that he called the highway patrol to be on its way, and that a tow truck would be coming in soon. In the middle of my helpless self, where I could not wrap myself around how I survived this accident, his presence, reassurance, and kindness were the most valuable gift any human could give to a total stranger like me.

When the highway patrol arrived, he helped them push my car to safety and free others from the traffic I was causing.

Supervisor Perico, I don't know about your faith, but Mr. Robinson was my guardian angel that day. I am not sure if I have seen any deputy so dedicated with excellent skills that genuinely act so quickly and humanely in an emergency.
