V. New Business

a. JJCC-Governance and Procedure Ad-Hoc Subcommittee's JJCC Consultant (Health Management Associates) Presentation/Discussion

Josh Green, Non-Profit CBO Supervisorial Representative District 3, introduced the agenda item. He stated there was an identified need to clarify the governance infrastructure and procedural questions regarding different areas. Additionally, he included a question about how to incorporate community voice in a meaningful way. By acknowledging the importance of the Brown Act parameters and to think of creative ways to work within the Brown Act rules. He stated it was an opportunity to hear from JJCC Consultants (Health Management Consultants). At the conclusion of the agenda item, he suggested allowing attendees who raise a virtual hand be allowed to make a comment without following the process to submit their request to make a public comment. Carol Clancy, Health Management Associates (HMA), introduced herself and stated that Health Management Associates is a healthcare consulting organization, and that their team is based in California. <u>Audio Time Stamp: 16:02-17:53, 18:10-19:27</u>

Carol Clancy, HMA, provided an introduction for Holly McCravey who was not present for the meeting. She began their presentation and provided a PowerPoint that was shown on screen during the meeting. She provided an

overview by stating HMA was tasked with reviewing four (4) different areas that included: 1: Strategic/Operational Framework, with the task to review the Bylaws to identify gaps and make recommendations and to also review and make recommendations on the JJCC process of CMJJP Development; 2: Ethical Practice Standards including identification of possible Conflicts of Interest, and JJCC members understanding of Conflict of Interest - additionally, to review Code of Conduct and Ethical Practice Standards; Management Assessments included a review of the process of the prioritizations on JJCPA funding and; 4. Accountability Framework included a review or assistance in the development of clear goals and objectives for the JJCC - additionally, to review performances metrics and outcomes and to review accountability. She indicated they have developed Process Improvement Focus Areas that included Scope of Work, Timing Issues, Process Issues and Norms and Resources. Regarding Scope of Work, they reviewed the relationship of the Subcommittees scope of work and the flow of information between the Subcommittees and the JJCC. They reviewed to determine if there were any redundancies or overlap of work. They also reviewed the process of information dissemination from the Subcommittees to the JJCC. Regarding Timing Issues, they included mapping of deadlines, having items placed on agendas and practices to ensure members have time to consult with constituencies. Regarding Process Issues and Norms, they reviewed next steps for each meeting, tracking decisions, reviewing the agenda templates and what the relationship is that exists between JJCC members and County Counsel. Additionally, when a question arises for County Counsel, how are those responses answered in a timely manner in a way that people can understand the feedback. She summed up by stating they had enjoyed the interviewers and found there are a lot of viewpoints. It is their goal to make recommendations to ensure viewpoints are heard and at the same time, to be able to follow the legislation of the JJCC. She asked her teammates whether they had anything to add. She moved on to indicate that they had five (5) questions for the JJCC-CAC members. She moved to the first question (shown on screen during the meeting). 1: What are your suggestions to make JJCC-CAC meetings more of an effective vehicle for public input? She stated that they were interested in feedback on ideas regarding how to make the JJCC-CAC more effective to have more voices heard.
