Gap Analysis 2024

• Focus of gap analysis

- Our interviews with programs were designed in part to identify groups of youth who have particular needs or are often marginalized
- With our gap analysis, we wanted to focus on exploring best practices related to serving at-promise and juvenile justice-involved youth within these marginalized groups
- Based on a review of our data and other guiding documents (e.g., CMJJP, Community Advisory Committee Youth Service Needs Assessment Survey), we have focused on LGBTQ+ youth

Gap Analysis 2024, cont.

• Methods

- Conducting comprehensive literature review
- Supplemented by key informant interviews and analysis of our existing interview data
- Final Report
 - Report 7: In progress, to be submitted to RAND quality assurance process in mid/late September
 - Expect to be ready for public release in December or early January
