Sharon Hawkins, Probation Department, provided an administrative summary to assist members. During the March 17, 2025, meeting, she provided an administrative summary, since we the minutes from the previous meeting were unavailable for their review, she provided a short administrative summary.

The Ad-Hoc Subcommittee (AHS) was created by a resolution adopted by the subcommittee with a two-part mission to update the plan and create funding recommendations. AHS composition was shown on screen and included: Co-Chairs, Tapau Osborne, LACOE, Josh Green, Non-Profit CBO Supervisorial Representative District 3, and Sam Lewis, Non-Profit CBO Supervisorial Representative District 1. The AHS met ten (10) times between June 2024 and March 27, 2025. Multiple meetings included discussions on what information should be included to streamline the process of requestion information needed when reviewing funding recommendations. Requests were sent to multiple agencies to obtain additional information regarding their budgets and information about the programming. An additional form was created for an agency to request the ability to utilize unspent funds in the following fiscal year. This was to ensure an agency that does not request future funding; this would provide them the ability to request the use of the funding in the next fiscal year. The AHS met several time to discuss unspent funds. As we stand now, the totals are very ahigh and this AHS is aware, and they were attempting to work through a spending plan.

This AHS has worked hard to provide information for you, and their work is not yet finished, as you will see regarding the funding recommendations. The AHS did the deep dives and ask tough questions to try to find answers to provide the best information for this body to be able to vote. She thanked the AHS for their dedication and commitment. 2. Motion to adopt FY 2025-26 Funding Recommendations

Luis Rodriguez, PD, JJCC-JJRBG Co-Chair, indicated he wanted to provide context regarding their work and delays. He stated there was a big concern, based upon the state auditor's report that there was close to \$100 million in JJRBG money that was just sitting there, and unfortunately, for numerous reasons, it's been sitting there. He stated that was in part due to the pandemic. Then there were administrative hurdles placed by the county and other agencies regarding not signing MOUs and or agreements.

He stated the AHC began to address by attempting to determine how to move through the process quickly to make sure the funds are distributed and to make sure they are administrated properly. There was a concern regarding how that money is being spent or not spent. The purpose of the funding is solely for our kids in SYTF. One concern was that AHS wanted to ensure administrative costs were limited. It had to be given top priority, and it must be spent. There were also discussions about spending money to upgrade facilities or improve facilities. Additionally, as we did with JJCC [for the JJCPA grant], the AHS discussion consensus was that there will be a mid-year review for the monies that are allocated. The review would provide the AHS and the public to have a full understanding as to how that money is being spent. Because our focus is the children. There should be some money spent on administrative costs, but they should not be substantial. Another concern emerged during review of the funding request submissions. This occurred right before the Chief Probation Officer, Viera Rosa, was to present this Global Plan before the Board of Supervisors. AHS's concern was what was going to come out of that plan. We know now that the intent is to move our boys, out of Campus Kilpatrick; to move all the girls and gender expansive youth out of Dorothy Kirby Center into Campus Kilpatrick and move the boys back to Barry J. Nidorf. There was a lot of disagreement in that, because some of us feel that's not the way that JJRBG was envisioned after Division of Juvenile Justice (DJJ) closed.

The AHS held healthy discussions regarding the recommendations presented. He reiterated, although this presents the potentially adopted allocations, there will be checks and balances, by having a mid-year review. As a reminder, the AHS adopted the inclusion

of a six month start up period. Normally the allocation period is for 12 months, but we all know the county is not as efficient as we would like for it to be in making sure those monies are able to be spent once agreements are in place (MOU's and agreements). Therefore, we decided to create a ramp-up time of six months for a total to create 18 months for funding allocations, to provide the extra time to ensure they would be able to overcome those bureaucratic obstacles. Luis Rodriguez, PD, JJCC-JJRBG Co-Chair, closed the discussion and would open it up for public comment. The AHS was in support of the funding recommendations, with the big caveat, that they were in support of less restrictive environments and then step downs. He stated they went into the recommendations with a strong message. Additionally, that the AHS members were not consulted or asked to opine with regards to what a global plan could look like. He ended by stating he hoped the Board of Supervisors would place a pause on the global Plan to make sure that the community voices and other county partners are included in the whole redevelopment or reimagining of a global plan. Sharon Hawkins, Probation Department, displayed the handout on screen. She began by providing descriptions of the columns across the the top of the spreadsheet that includes Fiscal Year's (FY), allocation, actual expenditures and balances. At the far right were two (2) columns that listed funding request and carryover request. On the far-left side, there were yellow highlighted rows and green highlighted rows. She directed them to the small legend at the bottom of the document. The AHS was recommending approval of funding in green. And to flag the items in yellow. The vote would be vote only for the green items. The AHS wanted to ensure work on the yellow highlighted items to obtain answers to questions to make informed decisions at a late date regarding unspent funds.

She provided the totals of the FY's and total unspent funds as follows: FY 2021-22 - \$8,031,596.00, expenditures zero, and unspent funds \$8,301,596.0.; FY 22-23 - \$30,248,564.00,

expenditures \$3,524,318.00 and unspent funds \$26,724,246.00; FY 2023-24-\$49,463,150.00, expenditures 12,031,81.00 and unspent funds \$37,431,337.00; FY 24-25: \$52,539,420.00. Total Allocations: \$195,552,730, estimated expenditures at that time-\$20,761,188.00. For all FYs, the totals included all allocations:\$195,552,730.00; Expenditures: \$36,317,319; Unspent funds: \$104,235,411.00. FY 25-26 estimated to receive: \$55,000.00. The AHS recommended the amounts shown on the spreadsheet to allocate \$35,543,558.00 and requests received from agencies to allow the ability to utilize unspent funds of prior years: \$22,455,320.00.
