### **GUIDING LIGHT HOME FOR BOYS FISCAL COMPLIANCE ASSESSMENT**

The Department of Children and Family Services (DCFS) Contracts Administration Division (CAD) conducted a Fiscal Compliance Assessment of Guiding Light Home for Boys (the Group Home) in January 2015. The Group Home has one licensed site in Riverside County and provides services to the County of Los Angeles Probation placed youth and youth from other counties. According to the Group Home's Program Statement, its stated purpose is "to provide care for boys who exhibit behavioral, social emotional difficulties".

At the time of the review, the Group Home served 12 County of Los Angeles Probation placed youth. The placed youth's overall average length of placement was eight months and their average age was 17.

### **SUMMARY**

CAD conducted a Fiscal Compliance Assessment which included an agency-wide review of the Group Home's financial records, such as financial statements, bank statements, check register and personnel files to determine their compliance with the terms, conditions and requirements of the Group Home Contract, the Auditor-Controller Contract Accounting and Administration Handbook (A-C Handbook) and other applicable federal, State and County regulations and guidelines.

The Group Home was in full compliance with 5 of 5 areas of the Fiscal Compliance Assessment: Financial Overview; Loans, Advances and Investments; Board of Directors and Business Influence; Cash/Expenditures; and Payroll and Personnel.

**GUIDING LIGHT HOME FOR BOYS  
FISCAL COMPLIANCE ASSESSMENT REVIEW  
FISCAL YEAR 2014 – 2015**

**SCOPE OF REVIEW**

The Fiscal Compliance Assessment included review of Guiding Light Home for Boys' financial records for the period of January 1, 2012 through September 30, 2015. Contracts Administration Division (CAD) reviewed the financial statements, bank statements, check register and personnel files to determine Guiding Light Home for Boys' (the Group Home's) compliance with the terms, conditions and requirements of the Group Home contract, the Auditor-Controller Contract Accounting and Administration Handbook (A-C Handbook) and other applicable federal, State, and County regulations and guidelines.

The on-site Fiscal Compliance Assessment review focused on five key areas of internal controls:

- Financial Overview,
- Loans, Advances and Investments,
- Board of Directors and Business Influence,
- Cash/Expenditures, and
- Payroll and Personnel.

The Group Home was in full compliance with 5 of 5 areas of the Fiscal Compliance Assessment: Financial Overview; Loan, Advances and Investments; Board of Directors, and Business Influence; Cash/Expenditures; and Payroll and Personnel.
