### COLBY FIRE UPDATE #2

**LOS ANGELES (Thu., Jan. 16, 2014 – 1 p.m. PST)** -- At 5:52 a.m. PST a brush fire broke out in the Angeles National Forest. The fire moved into the Los Angeles County area of Glendora. The Colby Fire has burned approximately 1,700 acres and 0 percent containment at this time. The Los Angeles County Emergency Operations Center (CEOC) is now activated to Level 3. The following is information about mandatory evacuations, school closures, shelter locations, and road closures:
