On February 27, 2007, on the motion of Supervisor Antonovich, the Board directed my office and the Probation Department to identify and report back with capital improvements, and related capital costs, at various Probation camps; and explore other suitable and available properties such as Barley Flats and the Angeles National Forest to potentially house Probation activities. We are currently finalizing the organization and presentation of single camp and phased construction options for improvements at various Probation camps, including capital costs. We plan to transmit our report on August 18, 2009.

At its meeting held February 27, 2007, the Board took the following action:

Supervisor Antonovich made the following statement:

"Last week, the Board instructed the Chief Probation Officer and the Chief Administrative Office to, among other things, identify and cost-out capital improvements at the camps. The Chief Probation Officer expressed the need for additional real estate which is not available at or near some of our camps. However, other suitable alternatives may be available and should be explored, such as Barley Flats near the Angeles Crest Highway and the Angeles National Forest."

Therefore, on motion of Supervisor Antonovich, seconded by Supervisor Knabe, unanimously carried (Supervisor Burke being absent), the Chief Probation Officer and Chief Administrative Officer were directed to include a review of other suitable alternatives, such as Barley Flats, in their report back to the Board regarding capital improvements at the camps, as requested at the Board meeting of February 20, 2007 (Board Order No. 89).
