



# MAJOR INCIDENT REPORT

Update to "Powerhouse Incident" 06/03/2013, at 12 noon (Assistance to Angeles National Forest)

### TYPE OF INCIDENT:

Brush Fire

### DATE AND TIME OF OCCURRENCE:

Original Dispatch: Thursday May 30, 2013, 3:32 p.m.

### INJURIES/FATALITIES:

Three firefighter injuries reported. All firefighters were treated on scene and released back to duty.

### INVESTIGATION STATUS:

The cause of this incident remains unknown with firefighters still on scene.

### INCIDENT UPDATE:

Fueled by 15-25 mile-per-hour winds, with gusts up to 40 miles per hour, the Powerhouse Fire is currently moving in a northwesterly direction and remains in the U.S. Forest Service jurisdiction within the Angeles National Forest. Our Department continues to assist. Forest officials are currently reporting 29,584 acres burned, with 40 percent containment. At this time, 2,185 firefighters are on scene battling this blaze. A total of eight structures have been destroyed, including six homes and two structures located at our Department's Lake Hughes Forestry Unit (the main building and the storage facility). More than 300 homes are currently being threatened in the community of Lake Hughes; 40 engines are prepared to protect those communities. Contingency plans are in place if more resources are needed. The American Red Cross has set up an evacuation center for displaced residents (details below); there are currently 150 residents at the shelter. There are no additional evacuation orders at this time, and not in the planning stage. Three firefighters (agencies unknown) were treated for minor injuries; all were treated on scene and released back to duty.

- A Red Cross evacuation center is located at Marie Kerr Park, 39700 30th St. W. Palmdale, 93551 for residents.
- Large Animal Shelter located at Antelope Valley Fairgrounds, 5210 W. Avenue I, Lancaster, CA 93536 has been discontinued but will be put back in place should the need arise.
- Small Animal Lancaster Animal Shelter, 5210 W Avenue I, Lancaster, CA 93536 or Castaic Animal Shelter, 31044, Charlie Canyon Rd, Castaic, CA 913536.

### COUNTY FIRE RESOURCES:
