On October 15, 2002, the Board approved a motion by Supervisor Burke, that instructed the Director of Public Health to provide quarterly reports which show the current funding allocations of Drug/Medi-Cal (DMC) programs by service modality, service planning area, and Supervisorial District. This is to provide you with the quarterly report for the period of April 1 through June 30, 2007, of DMC funded contracts.

Since 2002, DMC funding reports have been generated and forwarded to you on a quarterly basis. The reports show the current funding allocations of DMC programs by service modality, service planning area, and Supervisorial District. With the agreement of the Second District, we propose to discontinue sending these quarterly reports.

Any new agreements or changes in existing agreements which are implemented under delegated authority are always reported to the Board as they occur. Our inventory of DMC providers, treatment modalities, funding levels, and locations are continuously updated for these changes and is available to you at any time by request.
