(LAOMG) effective date of Board approval through November 30, 2007, and with an optional one month extension through December 31, 2007 for the provision of ophthalmology services at MLK MACC. At that time, the Department of Health Services (DHS) informed your Board of its intention to process an expedited RFI to determine whether alternative service providers would be able to provide these services at MLK MACC.

On October 15, 2007, DHS released an RFI for Ophthalmology Services at MLK MACC. The RFI was advertised in local newspapers and on the L.A. County Online and Department of Health Services websites. Additionally, a notice of the RFI was sent directly to 13 prospective providers. (See attached list).

By the October 29, 2007 deadline to submit responses to the RFI, only one prospective provider, LAOMG, the current contractor, submitted a response. DHS is currently evaluating LAOMG's response to determine if their response meets all the service needs and is in the best interest of the County.
