## QUITCLAIM OF COUNTY'S INTEREST IN THE PALMDALE CEMETERY TO THE CITY OF PALMDALE (FIFTH DISTRICT) (4-VOTES)

### IT IS RECOMMENDED THAT YOUR BOARD:

1. Find that the County's right, title, and interest in the Palmdale Cemetery as legally described in Exhibit "A" is not used nor claimed by the County.
2. Find that the proposed quitclaim conveyance is categorically exempt from the California Environmental Quality Act (CEQA).
3. Approve the quitclaim of the County's right, title, and interest in favor of the City of Palmdale in order to clear title and instruct the Chair to sign the Quitclaim Deed which has been approved as to form by County Counsel.

### PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The purpose of the recommended actions is in response to a request by the City of Palmdale, who is in process of acquiring title to the Palmdale Cemetery from a private party, to quitclaim whatever right, title, and interest, the County may have, if any, in order to remove a cloud on title resulting from an invalid tax deed given to the County in 1951. The City intends to restore and develop the Cemetery property, in combination with adjacent undeveloped land recently acquired from the County, into a pioneer memorial park for the benefit and use of all County residents.

### **IMPLEMENTATION OF STRATEGIC PLAN GOALS**

The proposed recommendations are consistent with County Strategic Plan Goal 1 (Service Excellence) and Goal 6 (Community Service) by assisting the City of Palmdale in its efforts to establish a new public park.

### **FISCAL IMPACT/FINANCING**

The proposed quitclaim of the County's interest in this property will have no fiscal impact on the County.

### **FACTS AND PROVISIONS/LEGAL REQUIREMENTS**

The Palmdale Cemetery, containing 2.52 acres, is located at 20<sup>th</sup> Street East and Avenue S in the City of Palmdale as shown on the attached map. The Cemetery was founded by some of the original settlers of the Palmdale area in the 1880s and has been used continuously as a cemetery since then. However, clear title to this property has been an ongoing issue for many decades. The County's involvement, as a possible claimant of title, stems from a tax deed given to the County by the Tax Collector and accepted by your Board on July 24, 1951 for this and several other adjacent and nearby tax defaulted properties for soil and water conservation purposes. After careful title examination by the Department of Public Works and review by the County Counsel, this tax deed and the tax default proceedings leading up to its issuance, as they pertained to this property, have been determined to be void, because of the exemption of cemetery property from ad valorem taxation under the State Constitution.

The conveyance of the County's interest, if any, for the purpose of removing defects in title is authorized by Section 25365 of the Government Code. The County Counsel has reviewed and approved as to form the attached Quitclaim Deed.

### **ENVIRONMENTAL DOCUMENTATION**

The recommended actions are categorically exempt from CEQA pursuant to Section 15316 of the State CEQA guidelines and Class 16 of the County's Environmental Document Reporting Procedures and Guidelines.

### **IMPACT ON CURRENT SERVICES (OR PROJECTS)**


The recommended actions will assist the City of Palmdale in developing a public park and will have no impact on current County services or projects.
