Adopt the resolution ordering annexation of territories to CLMD 1687 and 10006 and LLA-1, confirming a diagram and assessment, and levying of assessments within the annexed territories for Fiscal Year 2015-16, either as proposed or as modified by the Board; and

Adopt the joint resolutions between the Board and other taxing agencies approving and accepting the negotiated exchange of property tax revenues resulting from the annexation of these territories to CLMD 1687 and 10006 as approved by the nonexempt taxing agencies; and the proposed projects were found to be exempt from the provisions of the California Environmental Quality Act at the meeting of June 17, 2014. 6. Hearing to consider the proposed Santa Monica Mountains Local Coastal Program (LCP) as modified and approved by the California Coastal Commission. On February 18, 2014, the Board of Supervisors approved a proposed LCP for submittal to the Coastal Commission. At public hearings on April 10, 2014 and July 10, 2014, the Coastal Commission initially denied certification of the LCP as submitted by the County, but approved an LCP subject to the Coastal Commission's suggested modifications. It is the LCP with the Coastal Commission's suggested modifications that will be considered by the Board. The LCP includes the: Land Use Policy Map, Local Plan Amendment No. 2006-00008-(3) and Zone Change Case No. 2006-00009-(3), which would repeal the 1986 Malibu Land Use Plan, make zoning consistent with the Land Use Policy Map, and amend Title 22 - Planning and Zoning of County Code relating to the establishment of the Santa Monica Mountains Local Implementation Program, and other actions necessary to implement the Santa Monica Mountains Land Use Plan; and find that the project is consistent with the Los Angeles County General Plan. (The process to prepare and certify an LCP is exempt from the California Environmental Quality Act.) (Department of Regional Planning)

All persons wishing to testify were sworn in by the Executive Officer of the Board. Richard J. Bruckner, Director of Planning, addressed the Board and responded to questions. Gina Natoli, Principal Planner, and Joshua Huntington, Principal Planner, Department of Regional Planning, were also present. Larry Hafetz, Assistant County Counsel, also responded to questions posed by the Board.

Opportunity was given for interested persons to address the Board. Eric Preven, Don Schmitz, Ruth Gomez, Louise Rishoff, David Szymanski, Kathy Berkowitz, Jess Thomas, Bobby Shriver, Mark Persson, Paul Apodaca, and other interested persons addressed the Board. Correspondence was presented.

- 3. Made a finding that the LCP, including the LUP and LIP, as certified by the Coastal Commission is consistent with the Coastal Act and certified that when effective certification occurs as determined by the Executive Director of the Coastal Commission and jurisdiction is delegated to the County, the County will carry out the LCP consisting of the LUP and LIP in full conformity with the Coastal Act, including issuing coastal development permits, as required by the Coastal Act;
- 4. Adopted Zone Change No 2006-00009-(3), an ordinance to change the zoning designation in the Coastal Zone as part of the LIP as certified by the Coastal Commission, to take effect when effective certification of the LCP occurs and jurisdiction in the Coastal Zone is delegated to the County; and
- 5. Adopted a Zone Ordinance establishing regulations in the County Zoning Ordinance applicable to the Coastal Zone, to take effect when certification of the LCP becomes final.
