


















TOTAL LITIGATION EXPENSES



HEALTH SERVICES MEDICAL MALPRACTICE LITIGATION EXPENSES BY FACILITY FY 2014-15




HEALTH SERVICES EMPLOYMENT TOTAL LITIGATION EXPENSES





TOTAL LITIGATION EXPENSES










