22.56.196

Medical mMarijuana dDispensaries.

A. Purpose. This Section is established:

Subject to subsection (C), below, medical marijuana dispensaries which distribute, transmit, give, or otherwise provide marijuana to any person, are prohibited it shall be unlawful for any person to use or allow to be used, including renting, leasing, or otherwise permitting, any property, as a medical marijuana dispensary as defined in Section 22.08.130 - M, in allany zones in the County.
