This ordinance amends the proprietary petroleum pipeline franchise granted to Vintage Petroleum, Inc., a Delaware corporation, by Ordinance No. 2001-0059F, as amended, to reflect a transfer of the franchise rights in the Castaic / Val Verde / Del Valle unincorporated area to California Resources Petroleum Corporation, a Delaware corporation; extend the term of the franchise to December 31, 2020, and make other minor changes to clarify certain provisions in the ordinance.

ORDINANCE NO. 2016-0033F

An ordinance amending Ordinance No. 2001-0059F, as amended, a proprietary petroleum pipeline franchise granted to Vintage Petroleum, Inc., a Delaware corporation.

The Board of Supervisors of the County of Los Angeles ordains as follows:

SECTION 1. Section 1 of Ordinance No. 2001-0059F is hereby amended to read as follows:

SECTION 1. Franchise Term, Grant.

A. The right, privilege, and franchise is granted to ~~Vintage Petroleum, Inc.~~ California Resources Petroleum Corporation, a Delaware corporation (hereinafter "Franchisee"), and its successors and assigns, ~~for the period of fifteen (15) years,~~ through December 31, 2020, to lay, construct, reconstruct, maintain, operate, renew, repair, change the size of, and remove or abandon in place pipes and pipelines for the collection, transportation, and distribution of oil, petroleum, gas, gasoline, other hydrocarbon substances, wet gas, industrial gas, chemicals, mud, steam, water, waste water, and other liquid substances, excluding any hazardous substances or hazardous waste within the meaning of the "Comprehensive Environmental Response Compensation and Liability Act of 1980," 42 U.S.C. et seq., as it may hereafter be amended, the "Federal Water Pollution Control Act," 33 U.S.C. 1251 et seq., as it may hereafter be amended, and the "Solid Waste Disposal Act," 42 U.S.C. 6901 et seq., as it may hereafter be amended, together with all manholes, valves, cathodic protection systems, appurtenances, and connections necessary or appropriate for the operation of

said pipes or pipelines, including poles, conduits, wires, cables, and other appurtenances and equipment for telegraph or telephone lines, or both, necessary or appropriate solely for Franchisee's business operations in, under, along, or across any and all highways, as defined in Section 16.36.080 of the Los Angeles County Code, now or hereafter dedicated to public use within the following described service franchise area in the unincorporated territory of the County of Los Angeles (hereinafter, "County"), State of California, and depicted on the map attached hereto as Exhibit "A-1":

Part A: Santa Clarita/Castaic / Val Verde / Del Valle Unincorporated Area

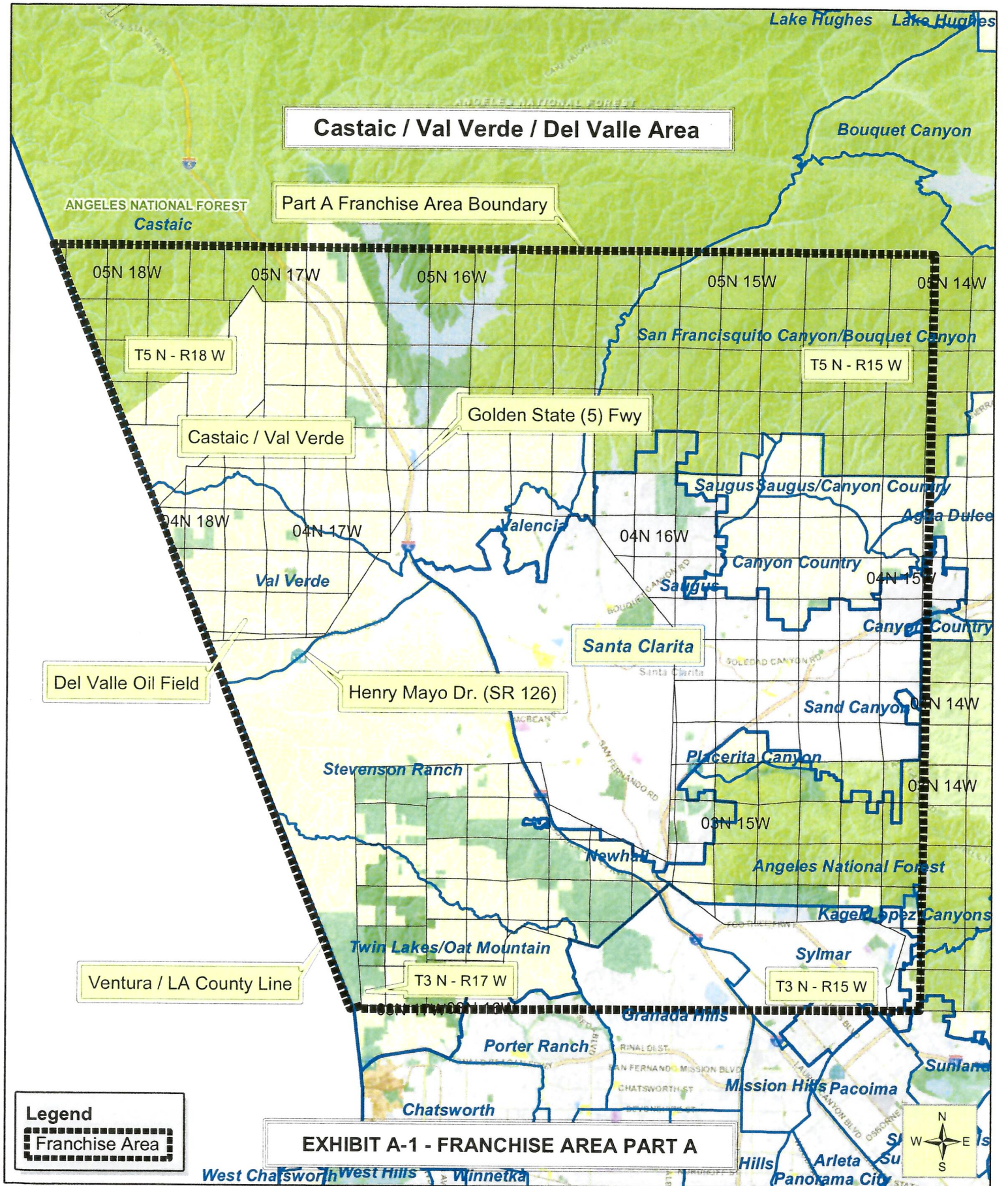
Those unincorporated areas of Los Angeles County lying within the following described boundaries:

Beginning at the intersection of the westerly prolongation of the southerly boundary line of Township 3 North, Range 17 West, San Bernardino Base and Meridian (hereinafter, "S.B.M."), and the westerly boundary line of the County of Los Angeles; thence northerly along the westerly boundary line of the County of Los Angeles to the intersection of with the southerly northerly boundary line of Township 95 North, Range 1918 West, S.B.M., ~~said township being the southerly boundary of Kern County~~; thence easterly along the southerly northerly boundary line of Township 95 North, Range 1918 West, S.B.M. and its easterly prolongation to the intersection with the westerly boundary of Township 5 North, Range 14 West, S.B.M.; thence southerly along the westerly boundary line of Township 5 North, Range 14 West, S.B.M. and its southerly prolongation to the intersection of with the southerly boundary line of Township 3 North, Range 15 West S.B.M.; thence westerly along the southerly boundary line of

Township 3 North, Range 15 West, S.B.M. and its westerly prolongation to the point of beginning, as same boundary lines of said townships and ranges existed on September 1, 1999.

B. The scope of the franchise shall not be expanded without the prior approval of the Board of Supervisors (hereinafter, "Board"). The operative date of this ordinance shall be July 26, 2016.
