CHANGES IN WORK FOR PUBLIC WORKS CONTRACTS ALL SUPERVISORIAL DISTRICTS 3 VOTES

IT IS RECOMMENDED THAT YOUR BOARD:

Find that the requested changes in work have no significant effect on the environment and approve the changes for the following construction contracts:

Project ID No. EN007162 - Alcazar Main Warehouse, City of Los Angeles (1), Best Roofing, Inc., in amount of \$9,588.00.

Project ID No. FCC0000872 - Project No. 5241 Low Flow Diversion at Westchester, City of Los Angeles (4), Clarke Contracting Corporation, in amount of \$124,650.00.

Project ID No. GME0000001 - Retrofit/Replacement of Underground Storage Tanks and Fuel Facilities, Group 1, vicinities of Downey, Malibu, Temple City, Pico Rivera, Baldwin Park, Glendora, South Gate, Los Angeles, and Sunland (1, 3, 4, and 5), Geo-Cal, Inc., in amount of \$33,300.00.

Project ID No. GME0000003 - Retrofit/Replacement of Underground Storage Tanks and Fuel Facilities, Group 3, vicinities of Claremont, Pasadena, Quartz Hill, Palmdale, and Malibu (3 and 5), Geo-Cal, Inc., in amount of \$10,379.11.

Project ID No. RDC0010883 - Crenshaw Boulevard, Palos Verdes Drive North to Silver Road, vicinity of Rolling Hills Estates (4), Excel Paving Company, in amount of \$40,200.00.

Project ID No. RDC0014146 - Vehicle Head Upgrade Project, vicinities of Industry, Rosewood, Hacienda Heights, and Glendora (1, 2, 4, and 5), Steiny and Company, Inc., in amount of \$25,449.59.

Project ID No. WWD2900012 - 10-inch Bypass at Pacific Coast Highway, City of Malibu (3), A. A. Portanova and Sons, Inc., in amount of \$55,500.00.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

This action is to obtain Board approval for changes in public works contracts in support of the timely completion of the projects while avoiding delays and the potential for claims. The descriptions of the changes, estimated costs, and necessary time extensions are listed in the enclosure for each contract.

The Director of Public Works has been authorized by your Board to order changes in work up to \$10,000 for construction contracts. Enclosed for your ratification are changes in work which I ordered for Project ID No. EN007162.

Enclosed for your authorization are changes in work in excess of my delegated limits which are required to complete Project ID Nos. FCC0000872, GME0000001, GME0000003, RDC0010883, RDC0014146, and WWD2900012.

Implementation of Strategic Plan Goals

Approval of these changes in work, which are necessary to satisfactorily complete the projects, is consistent with the County Strategic Plan Goal of Service Excellence since the improved infrastructure will better serve the public.

FISCAL IMPACT/FINANCING

The estimated change order amounts for these contracts range from \$9,588.00 to \$124,650.00.

If these changes in work are not approved, contract completion will be delayed and increased costs incurred.

Sufficient funds are available in the Board-approved appropriations for each of the respective projects to cover the costs of the requested changes. Detailed cost breakdowns for each of the changes, together with contract cost summaries, are included in the enclosures.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Each of the subject contracts for the construction of public works improvements was awarded by your Board to the lowest responsible bidder in accordance with the California Public Contract Code, your Board's directives, and as recommended by the Director of Public Works.

ENVIRONMENTAL DOCUMENTATION

The changes in work as described above and in the enclosures are within the limits of the Board-approved projects and do not change any conditions which resulted in the original environmental findings.

CONTRACTING PROCESS

Each contract provides that the contractor be compensated for changes in the work as a result of changes to the original plans and specifications or changed conditions encountered during the course of construction. The costs of each of the changes are based on contract unit prices, time and materials methods, or negotiated under the provisions of the contract specifications. The methods for arriving at the costs of the changes are included in the enclosures.

During removal of the old roof, asbestos material was encountered. It will be necessary to remove the asbestos at the price shown. The cost for this item was negotiated as provided in Subsection 3-2 of the contract specifications.

Description of Change:

To meet the requirements of the City of Los Angeles Department of Water and Power, it will be necessary to construct two electrical vaults and two retaining walls. The contractor must be compensated for the cost of the new vaults and walls and for the additional electrical work required. This work is not shown on the plans. The cost for this work was negotiated as provided in Subsection 3-2 of the contract specifications.

Thirty additional working days will be required because of these changes.

Description of Changes:

(1) In order to reinstall the Fuel Management System at various County facilities, additional equipment is necessary to accommodate for the additional fueling outlets at the dispenser pumps being installed. This work is not shown on the plans.

(2) Installation of a pedestal is necessary to support the reinstalled Fuel Management System. This work is not shown on the plans.

(3) It is necessary to replace the sensors on the existing tanks due to their incompatibility with the new Veeder Root System. This work is not shown on the plans.

(4) It will be necessary to connect the new waste oil tank to an existing public waste oil collection center. This work is not shown on the plans.

(5) To complete the project as intended, the location for electrical equipment and vent lines must be modified to accommodate existing obstructions not shown on the plans.

The cost for Items 1, 2, 3, and 5 will be based on time and materials methods as provided in Subsection 3-3 of the contract specifications. The cost for Item 4 was negotiated as provided in Subsection 3-2 of the contract specifications.

Eighteen additional working days will be required because of these changes.

(2) In order to reinstall the Fuel Management Systems, additional equipment is necessary to accommodate the two additional fueling outlets on the dispenser pumps being installed. This work is not shown on the plans.

The cost for Item 1 will be negotiated as provided in Subsection 3-2 of the contract specifications. The cost for Item 2 will be based on time and materials methods as provided in Subsection 3-3 of the contract specifications.

Two additional working days will be required because of these changes.

Two additional working days will be required because of this change.

Project Description:

Upgrading of traffic signal vehicle heads and installing audible pedestrian signals in various locations.

Changes in Work:

Description of Changes:

(1) The original contract amount is based upon estimated quantities of the various bid items. The contractor is paid based upon actual quantities used. The increase in contract price reflects the net adjustment due to variations between estimated bid quantities and actual quantities.

(2) Due to traffic signal upgrade at the intersection of 135th Street and Crenshaw Boulevard, it will be necessary to install additional electrical wiring to ensure correct operation of a new vehicle head. This work is not shown on the plans.

The costs for Item 1 will be based on contract unit prices. The cost for Item 2 will be based on time and materials methods as provided in Subsection 3-3 of the contract specifications.

No additional working days will be required because of these changes.

PROJECT ID NO. WWD2900012, 10-INCH BYPASS AT PACIFIC COAST HIGHWAY (City of Malibu), Supervisorial District 3, Contractor: A. A. Portanova and Sons, Inc.

Project Description:

Construction of three 10" bypass lines to temporarily bypass an existing 30" water main.

Changes in Work:

(1)	Modification of Connection Detail	\$15,000.00
(2)	Additional Work Due to Utility Conflicts	18,000.00
(3)	Additional Work and Delays Due to Subsurface Slab	5,000.00
(4)	Modification of Alignment	10,000.00
(5)	Exploratory Excavations	7,500.00

Description of Changes:

(1) An 8" gasline, which was not shown on the plans, conflicted with the connection of the proposed bypass lines to the existing water main. It will be necessary to modify the connection detail and compensate the contractor for the additional costs of material and labor.

(2) While trenching for the proposed 10" bypass lines, the contractor encountered several underground utilities which will conflict with the proposed waterlines. These utilities were not shown on the plans. It will be necessary to compensate the contractor for the additional work associated with protecting and avoiding these utilities.

(3) The contractor encountered a reinforced concrete slab under the pavement. The 10" bypass lines will need to be aligned around the slab. It will be necessary to determine the limits of the concrete slab and change the alignment and grade of the proposed bypass lines.

(4) The location of the existing 30" water main varies from the plans. It will be necessary to determine the exact location of the water main and realign a portion of the proposed bypass lines. The work includes additional exploratory excavations and saw cutting.

(5) It will be necessary to perform exploratory excavations to determine the exact location of underground utilities.

The costs for Items 1 through 4 will be based on time and materials methods as provided in Subsection 3-3 of the contract specifications. The cost for Item 5 is stipulated in the contract specifications.

Forty-seven additional working days will be required because of these changes.
