# FOURTH SUPERVISORIAL DISTRICT PARATRANSIT PROGRAM FISCAL YEAR 2009-10 (SUPERVISORIAL DISTRICT 4) (3 VOTES)

## **SUBJECT**

This action is to approve the Paratransit Program for Fiscal Year 2009-10 in the Fourth Supervisorial District.

## IT IS RECOMMENDED THAT YOUR BOARD:

- 1. Find that the proposed Paratransit Program is statutorily exempt from the provisions of the California Environmental Quality Act.
- 2. Approve the disbursement of \$664,000 from the Fourth Supervisorial District's Proposition A Local Return Transit Program for the continuation of paratransit services for eligible patrons in the unincorporated County of Los Angeles areas of the Fourth Supervisorial District for Fiscal Year 2009-10. The Fourth Supervisorial District's Paratransit Program includes the following services: Carson/La Rambla, Marina del Rey, Rancho Los Amigos, Teen Mother, and Whittier, et al.
- 3. Authorize the Director of Public Works or her designee to negotiate the following agreement for paratransit service in the Fourth Supervisorial District with the cost and term as indicated: the Rancho Los Amigos Paratransit Service, provided by the Los Amigos Research Education

Institute, Inc., at a cost to the Fourth Supervisorial District of \$207,000 for Fiscal Year 2009-10 (County's total cost for paratransit services in Supervisorial District's 1, 2, 3, 4, and 5 under this two-year agreement is \$610,000).

3. Instruct the Director of Public Works or her designee to sign the agreement.

#### PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The purpose of the recommended action is to approve the continuation of paratransit services for eligible patrons of the unincorporated County of Los Angeles (County) areas of the Fourth Supervisorial District and to authorize the Director of Public Works or her designee to negotiate and enter into an agreement with the Los Amigos Research Education Institute, Inc., for the provision of services.

#### Implementation of Strategic Plan Goals

The Countywide Strategic Plan directs the provisions of Operational Effectiveness (Goal 1) and Community and Municipal Services (Goal 3). This action provides services to the public in a responsive manner. These services improve the mobility of transit-dependent patrons.

#### FISCAL IMPACT/FINANCING

There will be no impact to the County General Fund.

This action authorizes the disbursement of \$664,000 for the continuation of paratransit services for eligible patrons in the unincorporated County areas of the Fourth Supervisorial District for Fiscal Year 2009-10. This Paratransit Program contains agreements with multiple-year terms; the costs for each fiscal year within each agreement will be submitted for your approval as part of future Paratransit Programs. Each agreement includes a 30-day, no-fault clause for termination.

One existing agreement will expire on June 30, 2009. This action authorizes the Director of Public Works or her designee to negotiate and enter into an agreement to continue service for a Fiscal Year 2009-10 expenditure of \$207,000. The agreement is for the Rancho Los Amigos Paratransit Service, provided by the Los Amigos Research and Education Institute, Inc., at a cost to the Fourth Supervisorial District of \$207,000 per year for two years, from Fiscal Year 2009-10 through Fiscal Year 2010-11.

Four paratransit services have agreements that were previously executed. The Carson/La Rambla Paratransit Service; the Marina del Rey Paratransit Service; the Teen Mother Paratransit Service; and the Whittier, et al., Paratransit Service are provided under existing agreements for a combined Fourth Supervisorial District Fiscal Year 2009-10 disbursement of \$457,000.

The Fiscal Year 2009-10 Paratransit Program Budget for the Fourth Supervisorial District totals \$664,000, which includes, with your approval, services authorized by your Board action for \$207,000 and the previously executed service agreements for \$457,000. The attachment lists these services with providers, terms, and the Fourth Supervisorial District's Fiscal Year 2009-10 contract amounts.

The necessary funds are available in the Fourth Supervisorial District's Proposition A Local Return Transit Program, included in the proposed Fiscal Year 2009-10 Transit Enterprise Fund Budget.

#### FACTS AND PROVISIONS/LEGAL REQUIREMENTS

On January 4, 1983, your Board directed that funds for paratransit services should be provided from each supervisorial district's allocation of the County's Proposition A Local Return Transit Program at the discretion of each supervisor. In Fiscal Year 1983-84, and in subsequent fiscal years, your Board approved paratransit services providing transportation opportunities for eligible patrons of the unincorporated County areas.

The agreements for the paratransit services are in compliance with the mandatory jury service requirements as set forth in the Los Angeles County Code, Chapters 2.203.010 through 2.203.090, Jury Service Program. The agreements are approved as to form by County Counsel prior to execution.

#### **ENVIRONMENTAL DOCUMENTATION**

The proposed activity is statutorily exempt from the provisions of the California Environmental Quality Act pursuant to Section 21080(b)(10) of the Public Resources Code. This exemption provides for the implementation of passenger or commuter transit services.

#### CONTRACTING PROCESS

The paratransit services for eligible patrons of the unincorporated County areas are provided primarily through participation in joint paratransit services with cities and other governmental agencies adjacent to the unincorporated County areas and less The Honorable Board of Supervisors May 12, 2009 Page 4

frequently through contracts the County enters into with private, for-profit or nonprofit, transportation service providers.

Through participation in joint paratransit services, the County benefits by a lower service cost due to economies of scale, better service to residents because of service coordination and, when available, subsidies provided through grants from the Los Angeles County Metropolitan Transportation Authority Proposition A Discretionary Incentive Grant Program (Incentive Grant Program). The Incentive Grant Program provides financial assistance to agencies that coordinate paratransit services across jurisdictional boundaries.

Most of the cities and other governmental agencies, that allow the County to partner with them, contract with private transportation service providers through a competitive selection and procurement process. The County's share of the cost of the service is proportionately based on the number of unincorporated County residents who use the service. When the County contracts directly with a transportation service provider, a competitive procurement process is used.

#### **IMPACT ON CURRENT SERVICES (OR PROJECTS)**

This action provides for the continuation of the current services. The approval of this action will not result in the displacement of any County employees.
