ACCEPTANCE OF PUBLIC WORKS CONTRACTS CITY OF EL SEGUNDO, THE ANGELES NATIONAL FOREST, AND THE SOUTHEAST AREA OF THE COUNTY OF LOS ANGELES (SUPERVISORIAL DISTRICTS 1, 2, 4, AND 5) (3 VOTES)

SUBJECT

This action is to ratify changes in work and accept completed public works construction contracts in the City of El Segundo, the Angeles National Forest, and the southeast area of the County of Los Angeles.

IT IS RECOMMENDED THAT YOUR BOARD ACTING AS THE GOVERNING BODY OF THE LOS ANGELES COUNTY FLOOD CONTROL DISTRICT:

Ratify changes in work and accept completed contract work under the following construction contracts:

- Project ID No. FCC0000979 Morris Dam Rehabilitation of Drum Gates and Azusa Conduit Inlet Gates, to repair and rehabilitate three spillway control drum gates and four slide gates, in the Angeles National Forest, Abhe & Svoboda, Inc., with a final contract amount of \$3,257,544.99 (Final Acceptance).
- Project ID No. FCC0001019 Santa Anita Dam and Reservoir Access Road Repairs, to construct pavement, metal beam guardrail, a steel soldier pile retaining wall, and drainage structures, in the Angeles National Forest,

Calex Engineering Company, with changes amounting to a credit of \$5,786.59, and a final contract amount of \$272,909.16.

- Project ID No. FCC0001035 Project No. 3401, El Segundo Pump Station Upgrade, to replace natural gas-fueled engines, retrofit actuators, and make mechanical and electrical modifications, City of El Segundo, S. S. Mechanical Corp., with a final contract amount of \$2,457,625.
- Project ID No. FMD0003102 Channel Right of Way Clearing, 2008, South Maintenance Area, to clear vegetation and debris from channel right of way, southeast area of the County of Los Angeles, Singh Group, Inc., with changes amounting to a credit of \$1,745.94, and a final contract amount of \$172,284.06.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The purpose of the recommended action is to obtain your Board's ratification of Director of Public Works-approved changes in public works contracts and your Board's acceptance of the work of the contracts in compliance with the provisions of the Public Contract Code. Included in the attachments are project and contract data, the scope of work of changes to be ratified, and the work of the contract to be accepted.

The Director of Public Works has been authorized by your Board to order changes in work up to \$10,000 for construction contracts. Changes to accommodate field conditions in order to meet the intent of the plans and specifications are not subject to this monetary limitation. Attached for your ratification are changes in work, which the Director of Public Works ordered for Project ID Nos. FCC0001019 and FMD0003102.

The projects have been completed, and it is recommended that your Board accept them on the date indicated in the attachments.

Implementation of Strategic Plan Goals

The Countywide Strategic Plan directs the provisions of Operational Effectiveness (Goal 1) and Community and Municipal Services (Goal 3). Acceptance of this contract completes the work to improve infrastructure and enhance the quality of life in the affected communities.

FISCAL IMPACT/FINANCING

There will be no impact to the County General Fund.

The modifications to the contract amounts are credits of \$1,745.94 and \$5,786.59, while the total values of the contracts range from \$172,284.06 to \$3,257,544.99.

Ratification of the changes in work and acceptance of the work of the respective contracts by your Board is in compliance with the acceptance and prompt payment provisions of the Public Contract Code.

Sufficient funds are available in the Board-approved appropriations for each of the respective projects to cover the total value of each of the contracts. Detailed cost breakdowns for each of the changes together with contract cost summaries are included in the attachments.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Each of these contracts for the construction of public works improvements was awarded by your Board to the lowest responsible bidder in accordance with the California Public Contract Code, your Board's directives, and as recommended by the Director of Public Works.

ENVIRONMENTAL DOCUMENTATION

The changes in the work as described above and in the attachments are within the limits of the Board-approved projects and do not change any conditions which resulted in the original environmental findings.

CONTRACTING PROCESS

Each contract provided that the contractor be compensated for changes in the work as a result of changes to the original plans and specifications or changed conditions encountered during the course of construction. The costs of these changes were based on contract unit prices, time and materials methods, or were negotiated under the provisions of the contract specifications. The original contract amount is based upon estimated quantities of the various bid items. The contractor is paid based upon actual quantities used. The increase in contract price reflects the net adjustment due to variations between estimated bid quantities and actual quantities. The changes resulted in a credit to the contract in the amount of \$5,786.59.

During construction, the contractor requested 2.5 hours of overtime inspection, which resulted in a credit to the contract in the amount of \$131.25.
