**ACCEPT A GRANT AWARD FROM CALIFORNIA EMERGENCY
MANAGEMENT AGENCY FOR FISCAL YEAR 2009-10
GANG VIOLENCE SUPPRESSION MULTI-COMPONENT PROGRAM
(FIFTH DISTRICT) (3 VOTES)**

SUBJECT

Authorize the Sheriff of Los Angeles County (County) to accept a grant award in the amount of \$350,000 with a 10 percent in-kind match of \$35,000 from the California Emergency Management Agency (CalEMA), formerly known as Office of Emergency Services, for Fiscal Year 2009-10 Gang Violence Suppression (GVS) Multi-Component Program.

IT IS RECOMMENDED THAT YOUR BOARD:

1. Approve and authorize the Sheriff, as an agent for the County, to accept a grant award in the amount of \$350,000 with a 10 percent in-kind match of \$35,000 from CalEMA for Fiscal Year 2009-10 GVS Multi-Component Program. The grant period is from July 1, 2009, to June 30, 2010.
2. Instruct the Chair of the Board of Supervisors to execute and provide a wet signature on the attached Certification of Assurance of Compliance (Attachment) as required by CalEMA to certify compliance with all grant requirements and to authorize the Sheriff to act as an agent of the County.

A Tradition of Service

3. Delegate authority to the Sheriff, or his designee, as an agent of the County, to execute the grant award agreement and all necessary grant documents, including amendments, modifications, augmentations, extensions, and renewals.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The Los Angeles County Sheriff's Department (Department) will utilize the GVS grant funds to implement the Antelope Valley Gang Violence Suppression (AV-GVS) Program.

The AV-GVS Program requires the collaborative efforts of the Department, the Los Angeles County District Attorney's Office, the Los Angeles County Probation Department, the Antelope Valley Union School District, and the United Community Action Network.

The primary purpose of this program is to reduce the level of gang violence in the Antelope Valley area and to divert dangerous gang activity into a more positive and constructive behavior.

Implementation of Strategic Plan Goals

This program is consistent with the County's Strategic Plan, Goal 1, Operational Effectiveness, by combining a multi-component group directed at reducing the prevalence of gang activity in the Antelope Valley area; and Goal 5, Public Safety, by implementing and developing an effective and strategic approach to reducing the crime and nuisance issues associated with gang activities, and improving the safety of residents of the Antelope Valley.

FISCAL IMPACT/FINANCING

The term of the GVS Program is for a period of 12 months, from July 1, 2009, to June 30, 2010.

Funding for the AV-GVS Program is in the amount of \$350,000 with a 10 percent match of \$35,000, to be contributed through in-kind match for a total program cost of \$385,000.

Funding for this program has been included in the Department's Fiscal Year 2009-10 Budget. The amount will be fully offset by grant funds.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

On August 17, 2009, a proposal requesting grant funding to implement the GVS Program was submitted to CalEMA by the Department on behalf of Lancaster Sheriff's Station in the amount totaling \$350,000.

The Department's Operation Safe Streets Bureau will provide a specially trained gang sergeant (as an in-kind contribution) who will supervise eight gang deputies over both the Lancaster and Palmdale Sheriff's Stations.

The AV-GVS will conduct gang, probation/parole, truancy sweeps, and other operations related to gang violence suppression, while working in conjunction with the County's Probation Department and the County's District Attorney's Office for successful prosecution. The County's District Attorney's Office will provide a full-time, trained, and experienced deputy district attorney, partially funded by the grant from its Hardcore Gang Division, to prosecute gang related crimes in the targeted community. The County's Probation Department will provide a deputy probation officer, partially funded by the grant, who will deliver delinquency prevention services and supervision to first-time offenders involved with gangs or drugs.

CalEMA has consistently awarded this grant to the Department. The Department, the lead agency, has applied and received grant funding for this program for the past 11 years.

The Attachment requires, among other things, that any liability arising out of the performance of the grant, including civil court actions for damages, shall be the responsibility of the County. The State of California and CalEMA disclaim responsibility for any such liability. Also, grant funds from CalEMA shall not be used to supplant expenditures controlled by the County.

This Board letter has been reviewed by County Counsel.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

The County's District Attorney, Public Defender, and Alternate Public Defender have determined that continuation of this program will not have a significant impact upon their respective departments.
