ACCEPTANCE OF A PUBLIC WORKS CONTRACT AND RELINQUISHMENT OF JURISDICTION SANTA ANITA CANYON ROAD CITY OF SIERRA MADRE (SUPERVISORIAL DISTRICT 5) (3 VOTES)

#### **SUBJECT**

This action is to accept the completed public works construction contract for Santa Anita Canyon Road in the City of Sierra Madre and relinquish County of Los Angeles jurisdiction over Santa Anita Canyon Road from 125 feet northerly of Arno Drive to 4,600 feet northerly of Arno Drive to the City of Sierra Madre.

#### IT IS RECOMMENDED THAT YOUR BOARD:

- 1. Accept completed contract work under Project ID No. RDC0015077 Santa Anita Canyon Road, for resurfacing and reconstruction of roadway pavement including installation of engineered paving mat, construction of PCC curb, metal beam guardrail, and concrete barriers, in the City of Sierra Madre, performed by All American Asphalt, with a final contract amount of \$571,888.75.
- 2. Adopt the Resolution declaring Santa Anita Canyon Road from 125 feet northerly of Arno Drive to 4,600 feet northerly of Arno Drive, within the City of Sierra Madre, is no longer a part of the County System of Highways.

#### PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The purpose of the recommended action is to obtain the County of Los Angeles Board of Supervisors' (Board) acceptance of the work of the contract in compliance with the provisions of the State Public Contract Code and relinquish Santa Anita Canyon Road back to the City of Sierra Madre. Included in the enclosures are project and contract data and the work of the contract to be accepted and the resolution relinquishing jurisdiction.

On May 6, 2008, Agenda Item 63, your Board adopted a resolution declaring a portion of Santa Anita Canyon Road, within the City of Sierra Madre, to be a part of the County System of Highways and requested jurisdiction for the purpose of constructing roadway repairs and improvements.

The project has been completed, and it is recommended that your Board accept it on the date indicated in the enclosures and adopt the enclosed resolution declaring Santa Anita Canyon Road from 125 feet northerly of Arno Drive to 4,600 feet northerly of Arno Drive is no longer a part of the County System of Highways and relinquishing jurisdiction to the City of Sierra Madre.

## <u>Implementation of Strategic Plan Goals</u>

The Countywide Strategic Plan directs the provisions of Operational Effectiveness (Goal 1) and Community and Municipal Services (Goal 3). Acceptance of this contract completes the work to improve infrastructure and enhance the quality of life in the affected communities.

#### **FISCAL IMPACT/FINANCING**

The total value of the contract is \$571,888.75.

Acceptance of the work of this contract by your Board is in compliance with the acceptance and prompt payment provisions of the State Public Contract Code.

A contract cost summary is included in the enclosure.

#### FACTS AND PROVISIONS/LEGAL REQUIREMENTS

This contract, for the construction of public works improvements, was awarded by your Board to a responsible contractor with the lowest responsive bid in accordance with the State Public Contract Code, your Board's directives, and as recommended by the Director of Public Works or her designee.

The enclosed resolution declares that Santa Anita Canyon Road from 125 feet northerly of Arno Drive to 4,600 feet northerly of Arno Drive is no longer a part of the County System of Highways and has been reviewed and approved as to form by County Counsel.

#### **ENVIRONMENTAL DOCUMENTATION**

The original environmental findings for this project were not changed.

#### **CONTRACTING PROCESS**

The contract provided that the contractor be compensated for changes in the work as a result of changes to the original plans and specifications or changed conditions encountered during the course of construction. The costs of these changes were based on contract unit prices, time and materials methods, or were negotiated under the provisions of the contract specifications. The final costs of the changes are included in the enclosure.

# **IMPACT ON CURRENT SERVICES (OR PROJECTS)**

Acceptance of the work stated in the contract by your Board will ensure the timely closeout of the contract, releasing departmental and County assets for other construction-related activities.
