IMPACT OF THE STATE'S EARLY RELEASE PROGRAM - AUGUST 2011 (ADMINISTRATIVE MEMO, AGENDA OF MARCH 2, 2010)

On March 2, 2010, your Board directed the Chief Executive Officer (CEO) to provide monthly reports on the impact the State's prison and parole reforms have on the Sheriff's Department (Sheriff), Department of Mental Health (DMH), and Department of Health Services (DHS). Our September 27, 2010, report to your Board advised you of DHS' request to be excluded from future monthly reports due to the lack of impact experienced. Therefore, the following is a summary of the impact on Sheriff and DMH since the implementation of Senate Bill X3 18 on January 25, 2010.

During the February 2, 2010 meeting of your Board, an outline was provided regarding three subgroups of individuals who are currently on parole or in State prison and whose change in status has the potential to affect service delivery in Los Angeles County. These groups, and their current impact on Los Angeles County Department of Mental Health, are as follows:

### Individuals Currently Residing in Los Angeles County Reclassified to Non-Revocable **Parole Status**

The first group is composed of individuals currently residing in Los Angeles County whose status will be reclassified to that of Non-Revocable Parole. The State of California has developed several measures in response to a federal court order to reduce the current State prison and parole population by 60,000 by the end of 2011. A provision that will reclassify the status of 7,700 parolees in Los Angeles County to that of Non-Revocable Parole was initiated on January 25, 2010 by the California Department of Corrections and Rehabilitation (CDCR). This provision eliminates the supervision requirement as well as eligibility for services provided by the Parole Outpatient Clinic (POC) system for those on Non-Revocable Parole. It is estimated that 1,200 of these individuals will have received mental health care from POC or while in prison and will no longer be expected to report to POC.

Between January 1, 2010 and February 5, 2010, DMH outpatient facilities treated individuals whose services were terminated by Parole Mental Health facilities as a result of the reclassification of their parole status. Until DMH receives identifying information regarding this group from CDCR, it is likely that this number will be significantly understated as it is based on the self-report of individuals who disclose the information when they initiate a request for services. Some individuals may be reluctant to report their involvement with CDCR; others may report additional referral sources (e.g., primary care) resulting in difficulties tracking the CDCR referrals. DMH continues to work with CDCR to obtain a full list of those in need of mental health services.

As of Friday February 5, 2010 DMH directly operated clinics reported having seen 24 individuals believed to be on parole or referred by Parole Outpatient Clinics since January 1. An additional two individuals believed to be on parole were seen by Emergency Outreach Bureau (EOB) PMRT or SMART during this period. As of February 4, outpatient service claims had been submitted through the DMH information system on six of these individuals at a total cost of \$4,977. Episode data indicates that both individuals seen by the EOB teams were subsequently admitted to DHS psychiatric emergency rooms then inpatient units during this period (estimated total cost is approximately ~\$16,230). An additional individual identified by DMH Countywide Resource Management as being on parole was admitted to a contracted inpatient facility during this period at an estimated cost of \$1,569.

### Incarcerated Individuals Slated for Early Release

The second group described in the February 2, 2010 meeting of your Board is composed of individuals currently in State prison who are slated for early release. This action has been stayed by court order and there is no current actual impact on the Department of Mental Health. Recent information provided by CDCR suggests that approximately 1,952 individuals currently incarcerated who are scheduled for release within the next six months will be placed on Non-Revocable Parole status and will, therefore, not receive outpatient parole mental health services once returned to Los Angeles County. The percentage that will require mental health services is yet to be determined. However, as previously reported, the potential impact on Los Angeles County, should this release occur, is estimated to be large.

### Individuals in State Hospitals

The third group includes individuals who have been residing in State hospitals as incompetent to stand trial on felony charges, those who are not guilty by reason of insanity or mentally disordered offenders. In these cases the individuals have been referred for Lanterman-Petris-Short conservatorships and courts have determined that they will not extend their penal code commitments. Over the course of the past year, the State has been returning many of these individuals to their Counties of origin – including Los Angeles County. Individuals in this group have severe mental health issues that required treatment in locked settings such as Institutes for Mental Diseases (IMDs) and State hospitals. Although the total number of individuals on criminal charges released from State hospitals may be small, the costs associated with their care are high. Since January 1, 2010 six individuals have been referred and converted to DMH State hospital beds at a cost of approximately \$85,000.

As requested, we will provide you with weekly cumulative reports regarding the number of individuals referred by CDCR and the total cost of their care so that your Board is fully informed of the impact of these changes on Los Angeles County. At your Board's February 8, 2010 meeting, Supervisor Antonovich requested the Chief Executive Officer, in collaboration with the Director of Mental Health, Interim Director of Health Services and the Sheriff, to provide weekly status reports beginning at the Board meeting of February 9, 2010 on the following: the fiscal impact on health and mental services being provided to patients resulting from the early release of inmates from State hospitals; the impact these additional services will have on the regular law-abiding clientele in mental health facilities and hospital emergency rooms; and an estimated cost that departments may incur for the provision of additional personnel and security enhancement.

### CURRENT WORKLOAD AND EXPENDITURE LEVELS

Since 2006, DHS facilities have admitted at least 25<sup>1</sup> individuals from the State prison system, with a median length of stay of 29 days. The estimated cost of care for these individuals during calendar year 2009 was \$1.82 million. During this time period some individuals were also referred to DHS that did not require placement.

### PROJECTED WORKLOAD AND EXPENDITURE LEVELS

At this time there is insufficient information to determine how many additional individuals may be released to Los Angeles County health facilities from State prisons or State hospitals, and what level of care they may require upon arrival. No additional information has been provided by the State. Therefore, it is not currently possible to develop estimates of the fiscal or service impacts of State plans to release additional individuals.

OF THE RELEASE OF INMATES TREATED IN STATE HOSPITALS

As requested by your Board during the meeting of February 20, 2010, the Department of Mental Health (DMH) has provided regular updates regarding the impact on services of the release of inmates from State Prisons. More specifically, DMH provided your Board with information on the impact of parolees whose status will be reclassified to Non-Revocable Parole by the California Department of Corrections and Rehabilitation (CDCR). During the course of these updates, DMH differentiated these issues from those related to the status of inmates who reside and are treated in State hospitals. This memo will provide you with an update on the activities of the workgroup formed to focus on issues related to release of those in State hospitals.

### Individuals in State Hospitals - Los Angeles County Workgroup

As previously reported, the Los Angeles County Department of Mental Health identified a group of individuals whose change in status has the potential to impact service delivery in Los Angeles County. This group includes individuals who have been residing in State hospitals as incompetent to stand trial on felony charges, those who are not guilty by reason of insanity or mentally disordered offenders. In these cases, the individuals have been referred for Lanterman-Petris-Short conservatorships and courts have determined that they will not extend their penal code commitments. Individuals in this group have severe mental health issues that required treatment in locked settings such as Institution for Mental Diseases (IMDs) and State hospitals. Although the total number of individuals on criminal charges released from State hospitals may be small, the costs associated with their care are high.

On Friday, April 9, 2010, the Los Angeles County workgroup reconvened for a second meeting to review the transition of individuals from Superior Court to the Los Angeles County Department of Mental Health. Participants from DMH, County Counsel, and Chief Executive Office reviewed an analysis of sixty individuals referred by the court system to the Office of the Public Guardian between March 2009 and March 2010.

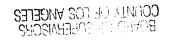
Several different groups of criminal case inmates were identified, and alternative approaches were identified. It was concluded that collaboration with the Court about the individual needs of clients as referrals are made is currently a successful approach; this course will be pursued and monitored on an ongoing basis. DMH will also explore options for engaging forensic experts that may assist with future evaluation and testimony should there be differences of opinion regarding clients' dispositions in the future.

The Los Angeles County workgroup will continue to meet on an as-needed basis to review the referrals and current approach. DMH will keep you informed of any developments related to release of inmates from State Hospitals and impact on service delivery. This memo will provide you with information recently received by Los Angeles County Department of Mental Health (DMH) regarding the protocol established by the California Department of Corrections and Rehabilitation (CDCR) for inmates with mental illness who are released from State prison on Non-Revocable Parole (NRP) status that have a need for continuing mental health services. Information regarding actions taken by DMH is also included.

### Background

During the March 2, 2010 Board meeting, representatives of the CDCR reported on several measures undertaken in response to a federal court order to reduce the current State prison and parole population by 60,000 by the end of 2011. A provision that will reclassify the status of 7,700 parolees in Los Angeles County to that of NRP was initiated on January 25, 2010, by CDCR. This provision eliminated the supervision requirement as well as eligibility for mental health services provided by the Parole Outpatient Clinic (POC) system for those on NRP.

### Incarcerated Individuals Slated for Early Release - CDCR Protocol

In reports to your Board, Los Angeles County Department of Mental Health (DMH) staff differentiated several populations of inmates affected by the new provisions. One group is composed of individuals who were incarcerated at the time the provision was enacted, who were to be released early on NRP status. During their presentation to your Board. representatives of the CDCR indicated that they would provide 30 days' prior notification of inmates' release to Los Angeles County. CDCR staff further indicated that a comprehensive referral packet would be provided several weeks prior to inmates' release in order to ensure continuity of mental health care for those treated for mental illness while incarcerated. It was anticipated that inmates identified for early release would begin to leave State correctional facilities in April. DMH was asked for a single point of contact and provided that information to the CDCR.

Since April 1, 2010, DMH has received only 2 referrals from CDCR, despite frequent inquiries. Minimal clinical information was provided for only one of these individuals. Based upon information provided by CDCR within the last 10 days, DMH has serious concerns that inmates with mental illness that are in need of ongoing mental health services and supports are being released early on NRP status without prior notification. According to information provided by CDCR, approximately 14% of the 2,000 individuals slated for early release on NRP status require ongoing mental health services. We are concerned that the lack of referral information precludes us from providing adequate outreach or coordination of care for individuals who may need ongoing mental health services in order to successfully integrate into our community.

### Actions Taken

Due to our concerns about being able to provide continuing mental health services to inmates released early on NRP status, I have sent the attached letter to representatives of CDCR. The letter requests that the CDCR take adequate steps to ensure that their protocols are followed. DMH staff also continues to contact representatives of CDCR on a regular basis to request referral information.

### **Department of Health Services**

Since February 2010, DHS has been reporting on the number of parolees that have been transferred directly from State prisons to DHS facilities. DHS received no new referrals from the CDCR in the month of August. On average, DHS has received two patients per month, which is consistent with past years before the implementation of the State's Early Release Program. Any increases previously noted in referrals are most likely due to better communication between CDCR and the DHS facilities.

Please note that the parolees that have been released into DHS' care have supervising parole officers, therefore, they do not have NRP status. NRPs by definition are not assigned parole officers and are no longer monitored and/or supervised by a parole officer. DHS has not seen a drastic increase in parolees since the State started the Early Release Program in January 2010.

As mentioned in previous reports, DHS likely serves many additional parolees that were not directly referred by the State. If a parolee is released into the community by the State, he or she would have the ability to enter the DHS system just like any other Los Angeles County resident. Similar to all DHS patients, these parolees will be assessed for third-party payer sources and will be billed accordingly. DHS does not collect information regarding parole status because it is not a prerequisite to receive healthcare services and has no impact on DHS' billing processes. Therefore, DHS has no systemic way to track the number of parolees that have recently been released from the State.

Since changes in the State's Early Release Program do not appear to be affecting the average number of parolees directly transferred to DHS facilities and DHS has no mechanism to track any additional parolees served from the community, DHS respectfully requests that their department be excluded from future monthly reports. However, DHS will notify your Board if the department experiences a significant increase in parolee transfer volumes.
